## ORDINANCE ADOPTING STATE MISDEMEANORS, VIOLATIONS AND OFFENSES AS MUNICIPAL ORDINANCE VIOLATIONS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CORDOVA, ALABAMA AS FOLLOWS:

Section 1--Any person or corporation committing an offense within the corporate limits of the City of Cordova, Alabama, or within the police jurisdictions thereof, which is declared by a Law or the Laws of the State of Alabama now existing or hereinafter inacted to be a misdemeanor, including but not specifically limited to those offenses defined and contained in Volume 12, Title 32A of the Code of Alabama, 1975 as amended, and Volume 17A Title 32 of the Code of Alabama, 1975, as amended; and Volume 14, Title 20 the Code of Alabama, 1975, as amended; shall be guilty of an offense against the City of Cordova, Alabama.

Section 2--Any person or corporation committing an offense within the corporate limits of the City of Cordova, Alabama, or within the police jurisdiction thereof, which is declared by a Law or the Laws of the State of Alabama, now existing or hereinafter inacted to be a violation, including but not specifically limited to those violations defined and contained in Volume 12, Title 13A of the Code of Alabama, 1975, as amended; and contained in Volume 17A, Title 32 of the Code of Alabama, 1975, as amended; and Volume 14, Title 20 of the Code of Alabama, 1975, as amended shall be guilty of an offense against the City of Cordova, Alabama.

Section 3--Any person or corporation committing within the corporate limits of the City of Cordova, Alabama, or within the Police Jurisdiction thereof, an offense as defined by Volume 12, Section 32A-1-2(1) of the Alabama Criminal Code, 1975, as amended, shall be guilty of an offense against the City of Cordova, Alabama.

Section 4--Any person found to be in violation Section 1, Section 2, or Section 3, of this Ordinance shall upon conviction be punished by such fine and/or jail sentence that the Municipal Court Judge of the City of Cordova, in the Judges discretion so orders, as long as such fine and/or imprisonment is in accordance with the Law or Laws of the State of Alabama.

Section 5--Any Ordinance heretofore adopted by the City Council of the City of Cordova, Alabama which is in conflict with this Ordinance is hereby repealed to the extent and only to the extent of such conflict. All prior Ordinances heretofore adopted by the City Council of the City of Cordova, Alabama, not directly in conflict with this Ordinance shall remain in full force and effect.

Section 6--If any part, section, or subdivision of this Ordinance shall be held unconstitutional or invalid for any reason, such holding shall not be construed to invalidate or impair the remainder of this Ordinance, which shall continue in full force and effect not withstanding such holding.

Section 7-- This Ordinance shall be effective on leptenha 27, 1994.
