

CITY COUNCIL OF THE CITY OF CORDOVA, ALABAMA

ORDINANCE NO. 04-2022

AN ORDINANCE OF THE CITY OF CORDOVA, ALABAMA, TO DESIGNATE THE FORM OF THE SERVICE & CREDIT APPLICATION & AGREEMENT TO BE UTILIZED BY THE CITY OF CORDOVA, ALABAMA, A MUNICIPAL CORPORATION OR ANY OTHER DEPARTMENT OR INSTRUMENTALITY OF THE CITY FOR NEW OR ADDITIONAL ACCOUNTS OR SERVICES AND TO ADOPT RELATED TERMS AND CONDITIONS.

WHEREAS, Section 11-45-1 of the *Code of Alabama* (1975) gives a municipality the authority to adopt ordinances which “provide for the safety, preserve the health, promote the prosperity, improve the morals, order, comfort and convenience of the inhabitants of the municipality;

BE IT HEREBY ORDAINED by the City Council of the City of Cordova, Alabama while in regular session on Tuesday, September 13, 2022, at 6:30 p.m. as follows:

A. Except where another specific application or form has been approved for use by the City of Cordova, Alabama (the “City”) or by the Water Works & Gas Board of the City of Cordova, or is required by applicable state or federal law, the City hereby directs that the form attached hereto as **Exhibit A**, whether in print or electronic form as described by the City’s Mayor, Superintendent, or Department Head as applicable, shall be utilized by the City for the establishment of new or additional accounts or services. The Mayor is authorized to direct changes to the style or to make typographical corrections as may be required or desired from time-to-time.

B. The City hereby adopts the Terms and Conditions set forth in **Exhibit A** as the official policy of the City. It is also the official policy of the Town to request, but not require, Social Security Numbers, when receiving the form attached hereto as **Exhibit A**.

C. This Ordinance shall become effective immediately upon its publication as required by law.

D. The sections, paragraphs, sentences, clauses and phrases of this Ordinance, including the contents of **Exhibit A**, are severable, and if any phrase, clause, sentence, paragraph and/or section of this Ordinance, including **Exhibit A**, shall be declared unconstitutional by a court of competent jurisdiction, then such ruling shall not affect any other section, paragraph, sentence, clause and/or phrase, since the same would have been enacted by the City without the incorporation of such section, paragraph, sentence, clause and/or phrase.
