**Things to consider and remember about the trip:**

- Bus will start loading at 6:00 a.m. and depart no later than 6:15. If you miss the bus, you must drive yourself, round trip. **No exceptions.**
- Bring your own snacks--drinks, food bars, cookies—and remember your medicines. There is no food available for purchase at the theatre except for roasted almonds.
- Handbags limited in size to 15" x 15" or smaller in theatre; bags checked at entrance.
- Restroom on bus (no stopping en route). Plenty of restrooms available at theatre.
- No photos allowed in theatre during performance.
