CALENDAR

- **March 16, 2026:** Deadline to receive paintings, along with a list of titles and prices for each painting, fee, and biography.
- **March 27 – May 2, 2026:** Exhibit dates.
- **March 16, 2026 Opening Reception:** Gallery will be open from 5pm – 7pm for an opening reception. A whiskey tasting will be added to the evening as a ticketed event. Admission to the museum will remain free of charge.
- **May 8-12, 2026:** Return of Entries and payouts for any sales will occur this week.

ELIGIBILITY AND GUIDELINES:

All artists must be members in good standing with WPA.

All entries must comply with WPA specified dimensions (see below). Please be sure to affix an official WPA label to the back of the entries with a legible name, address and title of the work. Please use screw eyes and wire on framed work. No unframed work, please.

Artists may enter up to 8 Whiskey paintings. Entries must have been created within the past three years.

SHIPPING:

Shipments must be made in strong REUSABLE cartons. All entries will be returned in the same cartons in which they were received. (Mark your carton clearly with your name.) Return shipping method is at the discretion of LCMA.

FEE:

\$53.00 for up to eight entries (\$3 of entry fee goes to WPA).

COMMISSION:

All entries must be for sale. A commission of 30% will be charged on all sales.

LIABILITY:

Artists must provide their own insurance. All reasonable care will be taken in handling and protecting entries. However, LCMA and/or the Whiskey Painters of America will not be responsible for loss or damage to submitted work, however caused. Submission of entries to this exhibition constitutes agreement to the conditions set forth above.

Permission to photograph work for press information is assumed.

WPA RULES:

All official WPA work must be done in watercolor and on paper of illustration board and should be done with some form of alcohol as a medium. The size cannot be larger than 20 square inches (image max. 3½ X 5½ or 4 X 5) and matted size not to exceed 8 X 10 or 9 X 10 inches.
