2. COPPA Compliance

- We value your family's privacy.
- In accordance with the Children's Online Privacy Protection Act (COPPA), we do not collect personal information from children under 13 without verified parental consent.
- Any information collected (name, email, birthday, mailing address) is obtained from the parent or guardian only and is used solely to provide membership benefits.
- We do not sell, rent, or share this information with third parties.
- Parents may review, update, or delete their child's information any time by contacting us at AdventuresOfLittleMissSue@gmail.com.

3. What's Included
