7 Puppies Health Agreement

Non-Transferable Agreement

This Health Agreement is exclusive to the original Client and is non-transferable. The Breeder, "7 Puppies," certifies that, to the best of its knowledge, the puppy at the time of adoption is free from lifethreatening diseases, including Parvovirus and Distemper. The Client will receive a vaccination record.

Health Conditions Not Guaranteed

Due to the natural susceptibility of puppies to various conditions commonly encountered in outdoor environments—such as grass, leaves, and contact with other animals—the Breeder cannot and does not provide any guarantee against such conditions, including but not limited to intestinal parasites, giardiasis, coccidiosis, mites, colds, mange, kennel cough, or any harm caused by medications or Client negligence.

Veterinary Exam and Severe Health Conditions

7 Puppies recommends that the Client take the puppy to a veterinarian within two (2) business days of arrival. If the veterinarian identifies a severe, life-threatening condition, the Client must notify the Breeder immediately. The Client must provide a licensed veterinarian's written certification of the health condition.

Replacement Policy

Upon notification and return of the puppy, and at the Client's option, the Breeder will either provide a replacement puppy, subject to availability, or a refund of the purchase price. The refund or replacement is limited to a forty-eight (48)-hour window after purchase. The Client must return the puppy with all documentation received at adoption. All veterinary expenses incurred after adoption are the Client's responsibility. Pet insurance is highly recommended.

Genetic Disease Guarantee

The Breeder offers a two-year genetic health guarantee from the puppy's birth date. If the puppy develops a genetic disease leading to its death within two years, a replacement puppy will be offered upon availability. To receive this benefit, the Client must provide veterinarian certification.

Client's Responsibility

By accepting this puppy, the Client agrees to provide appropriate veterinary care, including necessary vaccinations, parasite control, and heartworm treatment, and to feed the puppy high-quality food. This puppy is intended solely as a companion pet, and no warranties are made regarding its eventual size, color, coat, teeth, breeding ability, or conformation upon reaching maturity.

Proper Home and Care Requirements

The Client agrees that the puppy will live within the Client's home and will not be tethered or chained. The Client's commitment to care is essential for the puppy's health, growth, and development. In the event the Client cannot keep the puppy, the Client may return it to the Breeder with all original paperwork. The Client is expected to make a good-faith effort to rehome the puppy before returning it to the Breeder. Under no circumstances should the puppy be surrendered to an animal shelter, humane society, or rescue organization. If the Client is unable to rehome the puppy, it must be returned to the Breeder at the Client's expense; no compensation will be provided for the return.

Deposit Policy

All deposits are non-refundable. If an unforeseen incident affects the puppy while under the Breeder's care, the deposit may be refunded at the Breeder's discretion.

Ownership Transfer

Ownership of the puppy transfers to the Client only upon the puppy's departure from 7 Puppies' premises. If issues arise, the Client should communicate directly with the Breeder for resolution.
