

Nature's Coastal Holiday – Fundraiser for Azalea Park Improvements

Official Rules Effective Date May 25, 2018

Price of raffle ticket; \$5.00 or 5 tickets for \$20.00 (no refunds will be issued)

1. Eligibility: The Great Holiday Hoopla Giveaway (the "Raffle") is open only to those who purchase a ticket and deposit a legible and complete ticket stub in an official container and who are 18yrs of age as of the date of entry. Board Members of Nature's Coastal Holiday (the "Sponsor") and their immediate family members and/or those living in the same household of each are not eligible to participate in the Raffle. The Raffle is subject to all applicable federal, state and local laws and regulations. Void where prohibited.

2. Agreement to Rules: By participating, you agree to be fully and unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of Nature's Coastal Holiday, as final and binding as it relates to the Raffle.

3. Raffle Period: Raffle tickets go on sale midnight PST, May 25, 2018 through December 23, 2018 at 6:00pm PST.

4. How to Enter: The Raffle must be entered by purchasing a raffle ticket. The entry must fulfill all raffle requirements, as specified, to be eligible to win a prize. Tickets will also be available at numerous community events throughout the year and at the Festival of Lights at Azalea Park during show hours.

Winner selection and notification: Winners of the Raffle will be selected in a random drawing from the entries submitted under the supervision of the Sponsor on December 23, 2018 at 7pm during Nature's Coastal Holiday Festival of Lights in Azalea Park. Drawing will begin with 14th prize and move up the list to the Grand Prize. Individuals who purchase more than one ticket are eligible to win more than one prize. If weather does not permit the drawing to occur, an alternate time and location will be announced on December 23, 2018 by 5pm. The location will be made public via naturescoastalholiday.com and on Nature's Coastal Holiday Facebook page. Winner need not be present to win.

Winners will be notified via the contact information they entered the ticket stub within five (5) days following the winner selection. In addition, Nature's Coastal Holiday will publish the names of the winners at naturescoastalholiday.com within five (5) days following the winner selection. Nature's Coastal Holiday shall have no liability for a winner's failure to receive notices due to winners' email security settings or for winners' provision of incorrect, omitted or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 30 days, Nature's Coastal Holiday will select another winner chosen from the remaining entries. If winner fails to return a completed and executed declaration and releases as required within 30 days of contacting Nature's Coastal Holiday, prize may be forfeited and an alternate winner selected. After the winner has been notified and claims the prize, returning the executed documents, prize shall be held in a trust for a period of one year from the date of the draw. If at that time the prize is unclaimed, the prize shall be donated to Nature's Coastal Holiday. If the winner claims a prize after the date the prize has expired it shall be no fault of Nature's Coastal Holiday and the prize will be voided.
