**Contribution limits:**

- \$2,900 for the Primary Election and \$2,900 for the General Election
- A couple may contribute up to \$5,800 for the Primary Election and \$5,800 for the General Election from a joint bank account (Total of \$11,600)
- Multi-candidate PAC's are limited to \$5,000 for the primary election and \$5,000 for the general election (Total of \$10,000)
- All individual, partnership or PAC contributions that exceed, in part or in their entirety, the federal contribution limit for the Primary 2022 cycle will be applied to the General 2022 contribution limit.
- Unless specified or designated differently, all contributions that exceed \$5,800 by individuals or \$10,000 by multi-candidate PACs will be applied to the 2022 Election Debt subject to federal limits for such election and applicable law.
- Contributions to Bob Healey for Congress are not tax deductible for federal income tax purposes. Contributions by federal contractors, corporations, foreign nationals, labor unions are prohibited.

Partnerships and Limited Liability Companies (LLCs) may contribute the same amount as individuals \$2,900 for the Primary Election and \$2,900 for the General Election so long as they have elected to be treated as a partnership for federal income tax purposes and no portion of the contribution is attributed to a corporation, foreign national, or other prohibited source. Please include a letter attributing the contributions among the individual partners.
