#### **ENTRY FORMS**

## Western Dressage Test Entries MUST be mailed to our show secretary and postmarked by 6/14/25. Day-of-show entries for Western Dressage tests will NOT be permitted.

All entries must be made in writing on an official entry form for this show. Include the name, address, and signature of the registered horse owner and the agent or trainer (sign both lines if trainer is also the owner). Payment by check, credit card, or open check (see Show Tabs) should accompany entry form. Copies of all required documentation of ownership and eligibility to show must accompany the entry form. A \$10 fee will be charged for any incomplete entry form. Exhibitors are responsible for any error on an entry form. Exhibitor packets and back numbers will not be released until all entries are complete.

#### **RIDE TIMES**

Ride times will be assigned the Thursday prior to the show. Ride times are not necessarily in order of classes. Requests may be made for specific ride times, but are not guaranteed. Day-of-show changes to horse/rider/test/level will be added to the end of the day. The show will be limited to the first 60 rides.

#### **TBAs**

Arabian and Open Breed WDAA classes up through level 4 may be added if show secretary is contacted by 6/14/2025. Classes may NOT be added day-of-show. TBAs will incur a fee of \$30. The fee is waived if 3 or more riders enter the class.

\*\*Therapeutic Riding Tests for WDAA Exceptional Riders may be added to the schedule with no fee\*\* Please read entry guidelines from WDAA <a href="here">here</a>. To allow us time to accommodate these tests, please submit entries by 6/14/2025 and/or contact the show secretary or show manager ahead of time.

#### **SHOW OFFICE**

The show office will be open for check ins on Friday 6/27 from 4:00-8:00 pm. The show office will open at 6:30 am on Saturday and Sunday. PHONE: 816-668-4447

#### **STALLS**

Stalls MUST be reserved by Wednesday, 6/25/2025. If you have not submitted entries including stalls, you must contact the show manager Pamm Payne directly to reserve stalls.

Stall assignment will be sent out on Thursday, 6/26/25. Stalls are permanent box stalls with doors. Payment in full must accompany stall reservations. Telephone stall requests are not guaranteed. Stall fees are not refundable, whether used or not.

#### **REQUIRED DOCUMENTATION**

#### Copies of the following must be submitted at the time of entry:

- ☐ HORSE REGISTRATION CERTIFICATE (front and back) for A/HA classes only
  - A horse must be entered in the name of the registered owner(s) only.
  - If owner is an entity (farm/ranch/corporation, etc), the horse may be shown in AOTR/JOTR classes if the exhibitor's family is the sole owner of the farm/entity.
  - Sale of a horse does not eliminate this requirement. "Contracts of Sale" or "Bill of Sale" will not be accepted.
- ☐ AHA MEMBERSHIP AND COMPETITION CARD for A/HA classes only
  - If you are not a current AHA Competition member, you must pay a \$40 Single Event Membership fee or purchase an annual membership and card.
    - For AHA non-members the AHA Single Event Member Fee @\$40.00 needs to be paid directly to AHA online before the show starts.
  - An exhibitor in Amateur/Junior Owner classes must be the registered owner or a family member of the registered owner of the horse they are showing.
  - For a horse owned by an entity (including but not limited to: a corporation, farm/ranch, trust, syndicate, partnership, or estate) a copy of the AHA Business Membership must be presented, or a Single Event Membership Fee of \$40.00/person will be charged.
- OPEN BREED CLASSES DO NOT REQUIRE REGISTRATION CERTIFICATE OR AHA MEMBERSHIP AND COMPETITION CARD
- ☐ USEF Competition Membership is required for anyone signing the entry blank as Trainer or Coach. USEF membership needs to be paid online directly to USEF before the show starts. USEF membership is not required for riders.

#### AHA MEMBERSHIP STATEMENT FOR AHA CLASSES ONLY

EACH COMPETITOR (THIS INCLUDES AT LEAST ONE RECORDED OWNER AND ALL TRAINERS, DRIVERS, RIDERS, HALTER HANDLERS, COACHES AND THE PERSON(S) SIGNING THE ENTRY BLANK) IN AN ARABIAN HORSE ASSOCIATION RECOGNIZED ARABIAN DIVISION, AT THE TIME OF ENTRY INTO A COMPETITION, MUST SUBMIT A COPY OF A VALID AHA MEMBERSHIP/COMPETITION CARD, JOIN AHA OR PAY AN AHA SINGLE EVENT MEMBERSHIP FEE PER COMPETITOR.

## For AHA non-members the AHA Single Event Member Fee @\$40.00 needs to be paid directly to AHA online before the show starts.

WHEN AN AGENT SIGNS FOR THE OWNER AT AN AHA RECOGNIZED COMPETITION, BOTH THE OWNER AND AGENT MUST BE MEMBERS OF AHA OR PAY THE AHA SINGLE EVENT MEMBERSHIP

MEMBERS OF AHA OR PAY THE AHA SINGLE EVENT MEMBERSHIP.
SINGLE EVENT MEMBERSHIP IS NOT ACCEPTABLE AT AHA REGIONAL OR NATIONAL COMPETITIONS.

EXHIBITORS IN WALK-TROT CLASSES ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS AT QUALIFYING COMPETITIONS, BUT MUST HAVE AN AHA MEMBERSHIP WITH COMPETITION CARD AT AHA REGIONAL AND NATIONAL COMPETITIONS.

EXHIBITORS IN LEAD LINE CLASSES OR PARENTS/GUARDIANS SIGNING FOR MINORS ARE EXEMPT FROM AHA MEMBERSHIP REQUIREMENTS. (BOD 5/12)

#### **USEF MEMBERSHIP STATEMENT**

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above, Combined Driving Competitions at the Advanced Level, Dressage Competitions, Endurance Rides and Vaulting Competitions: (See GR828.4 of the Federation rules). Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes

USEF Competition Membership is required for anyone signing the entry blank as Trainer or Coach. USEF membership needs to be paid online directly to USEF before the show starts.

#### **WDAA MEMBERSHIP STATEMENT**

This show is a WDAA recognized show. <u>WDAA Membership is not required</u> for exhibitors participating in USEF Lite competitions but may offer benefits to riders including achievement points. More information can be found on their <u>website</u>.

#### **AMATEUR/JUNIOR OWNER CLASSES**

For Amateur/Junior Owner classes (AOTR/D/H, JOTR/D/H, AOTS), the exhibitor or a member of the exhibitor's family must be the horse's registered owner, as defined in <u>USEF AR110.4</u>. Horses registered in a farm/syndicate/partnership/corporation or other entity name may be shown in owner classes if the exhibitor's family is the sole owner of the farm or entity as defined in <u>USEF AR110.4.d.e.f.</u> The sale of a horse does not eliminate this registration requirement. (Contracts of Sale or Bill of Sale will not be accepted in Owner classes.) Competitor must be an amateur/junior exhibitor AND a recorded owner of the horse or a family member of the recorded owner(s).

Family members include: spouse, parent, step-parent, child, step-child, brother, sister, half brother and sister, aunt, uncle, niece, nephew, step-brother and sister, grandparents and grandchildren and in-laws of the same relation as stated above. Combined ownership is permitted in Owner's or Amateur Owner's classes. Refer to USEF AR110.4.e.1-11.

Owner classes may be restricted to riders, drivers or handlers who are no longer eligible to compete as a junior exhibitor.

#### **OWNERSHIP REQUIREMENTS**

Ownership of any entered horse must be clearly stated on the entry form. Any deviation between registration papers and entry form must be supported by contract, etc. A copy of proof of ownership must be included with entry form.

#### **RULES OF ENTRY**

Please read the following relevant rules from the WDAA. Also see WD102 Participation in Western Dressage Competitions available through WDAA/USEF.

- 1. Western Dressage classes are open to riders on horses, mules and/or ponies of any origin. Classes may be restricted to one or more breeds at a licensed breed restricted competition.
- 2. A Horse/Rider combination may enter no more than two consecutive levels, Freestyle levels included, at any one competition. Suitability, Hack and Equitation are excluded from the maximum limit of rides per day and horses in these classes may compete at any level for which they are otherwise eligible during the same competition.
- 3. Horse/rider combinations may ride the same test twice at the same competition, given they are separate class numbers.
- 4. No horse may be ridden more than once in any Western Dressage class including separate sections of the same class number.
  - a. Horses may be ridden in junior, amateur, and open sections at the same competition.
- 5. Horses cannot be ridden by more than two riders. Shows may further limit number of rides per horse and level if stated in their prize list.
- 6. If there is a conflict with breed division rules regarding WD102.2-4, the breed division rules will govern.

#### **SIGNATURES**

Entries will not be accepted without required signatures. Signature by a parent/guardian is required if the exhibitor is a minor. Minors are not allowed to sign as either owner or trainer.

#### WITHDRAWAL OF ENTRY

CLASS ENTRY FEES will be refunded for horses withdrawn from entry ONLY if excused by Show Management in writing. Refund will be issued upon presentation of a signed and dated veterinarian's certificate, delivered in person or mailed to the Show Secretary on or before the end of the last class of the show. <u>UNDER NO CIRCUMSTANCES WILL STALL OR OFFICE FEES BE REFUNDED.</u>

#### **SUBSTITUTION OF SHOW STAFF MEMBERS**

In the event of illness or failure of a Staff Member to attend the show or perform his/her duties, the Show Committee reserves the right to substitute another Staff Member in his/her place.

#### **INDEMNITY AND NON-RESPONSIBILITY CLAUSE**

All entries are accepted with the understanding that the Greater Kansas City Arabian Horse Association, nor the Longview Horse Park will be responsible for loss, personal injury or damage to horses exhibited; or for any article of any kind or nature that may be lost, destroyed or in any way damaged. Each exhibitor will be responsible for any injury that may be occasioned to any person, or any animal, or damage of any property while on the show grounds by any horse owned or exhibited by him/her; and shall indemnify the Management against all legally established claims or damage of any kind or nature that may grow out of any injury occasioned by any horse owned or exhibited by him/her, or arise from negligence of the person in charge of any such horse. The submitting of an entry form to the Show Secretary shall constitute an acceptance of each person that signed same of the provisions herein set forth.

#### **GENERAL SHOW INFORMATION**

This horse show is conducted in accordance with the rules of AHA. Judging, class specifications, rules and conduct shall be in accordance with the current USEF Rulebook, Arabian Horse Division.

#### **ARRIVAL & DEPARTURE TIME**

Stall assignment will be sent out on Thursday, 6/26/25. Stalls will be available the night before the show. The show grounds and office will be open for check-in from 4:00-8:00 pm on Friday, 6/27, 7:00 am – 8:00 pm on Saturday, 6/28, and at 7:00 am on Sunday, 6/29. Check-ins are not permitted outside of these hours. Do not stall a horse unless stall has been assigned. Horses must be removed from the show grounds after the conclusion of the show.

#### **BEDDING/SHAVINGS**

No bedding will be furnished with stalls. Shavings will be available for purchase. Straw will not be available for purchase.

#### **STALLS**

Stall assignment will be sent out on Thursday, 6/26/25. Stalls are permanent box stalls with doors. Payment in full must accompany stall reservations. Telephone stall requests are not guaranteed. Stall fees are not refundable, whether used or not.

#### **ARENA**

All tests and warm-up will be ridden in outdoor arenas (sand footing). Competition arenas follow the regulations of USEF/WDAA with the small arena measuring 20m x 40m and the large arena measuring 20m x 60m. All arenas must be vacated while facility equipment is being used. Schedule for schooling will be posted at the show grounds.

#### **SHARPS CONTAINERS**

Sharps containers for the disposal of needles and other disposable sharp instruments (1 container for every 50 occupied stalls) will be placed in convenient locations in barns housing competition horses. These containers when full will be disposed of properly. Competition management may fine any individual (including trainer, owner, exhibitor, or agent) up to \$100.00 for improper disposal of needles or other sharp disposable instruments.

#### **INSURANCE ADVISORY**

Due to the number and quality of horses at this show, we urge each exhibitor to verify their liability insurance and livestock mortality coverages are in effect. The Greater Kansas City Arabian Horse Association, its members, agents, employees, and volunteers accept no responsibility for losses sustained or caused by any exhibitor.

#### **MOTORIZED VEHICLES**

No motorized or other vehicle (scooter, golf cart, etc.) is allowed in the arena, paddock, or schooling areas unless operated by a show official. When operating vehicles in other areas, please adhere to safety rules and be considerate of horses, exhibitors, and spectators.

#### **PARKING**

Park only in designated areas. Parking any vehicle or trailer in illegal areas or fire lanes will result in the vehicle being towed at the owner's expense.

#### **DOGS**

Dogs must be kept on a leash at all times. No dog will be allowed in the Show Arena at any time.

#### **INCLEMENT WEATHER**

Longview Horse Park has excellent drainage in the warm up and show arenas, with low likelihood that muddy footing will cancel the show. If necessary, rain delays will be announced. All attempts will be made to continue the show. If the show cannot be held due to extensive periods of heavy rain or other extenuating circumstances, the show will be rescheduled for another weekend in the summer based on availability of Longview Horse Park. Show fees and entries will be automatically transferred to the new date.

#### RULES AND REGULATIONS

These Rules and Regulations are established for the fair, equitable and efficient management of this show in compliance with USEF/WDAA/AHA Rules and Guidelines. The Show Management reserves the right to make changes in procedure, personnel, rules and regulations not governed by the previously mentioned organizations determined by them to be in the best interest of the show.

#### **ADMISSION TO ARENA**

No person will be admitted to the arena except participants in the class, judges and their assistants, official show personnel, and the show photographer and his or her assistant. Attendants will not be permitted in the arena until summoned by order of the Judge.

#### **AGE OF RIDER**

The age of a rider is determined as of December 1st of each year and maintained until December 1st of the following year.

#### **COMMUNICATION DEVICES**

Use of any electronic/radio communication devices is prohibited in the show arena.

#### **CRUELTY**

CRUELTY TO OR THE ABUSE OF A HORSE BY ANY PERSON AT A RECOGNIZED SHOW IS FORBIDDEN. PENALTY FOR CRUELTY WILL BE ENFORCED TO THE FULL EXTENT OF THE RULES AND LAW. Such actions could include, but are not limited to, excessive use of whips or spurs.

#### **DISCOURTESY/DISOBEDIENCE**

Exhibitors are warned that any act of discourtesy or disobedience to show officials by the owner, groom, rider, driver, or handler will disqualify the horse for further adjudication. Show management reserves the right to remove a groom, horse, rider, driver, or handler from the show without liability for compensation or damages. It is a violation of AHA Rules to commit any act or make any remark during the show that is considered offensive or intended to influence or cast aspersions on the judging. Show management reserves the right to bar an exhibitor from the show for these offenses.

#### **DISQUALIFICATION**

All horses doctored in any way, artificially, improperly or unfairly prepared or tampered with before entering the show ring will be disqualified. If it is ascertained that any exhibitor has made, or caused to be made, any false statement regarding any animal or article exhibited, or if any exhibitor shall attempt to interfere with the judges in the performance of their duties, the exhibitor shall be excluded from competing or exhibiting. If any horse is disqualified after being awarded a prize in a class, the winner of the next succeeding prize in the class shall claim the prize previously awarded to the disqualified horse.

#### HEALTH CERTIFICATE (INTERSTATE) AND COGGINS TEST —You Must Have A Copy

The State of Missouri requires a <u>valid health certificate</u> for every horse from another state entering Missouri. <u>Any horse six months and older entering Missouri from another state shall be accompanied by an official health certificate from the state of origin, proclaiming the animal to be free from symptoms of any infectious disease or exposure thereto. Health certificate must be issued by a state, federal, or licensed accredited veterinarian stating that examination was made within thirty (30) days prior to start of the horse show.</u>

The State of Missouri also requires proof of a negative Coggins test on ANY HORSE exhibited in the state. Coggins Test Certificate must be dated within twelve (12) months prior to the date of show. <u>Stall assignments will not be made without proof of a negative Coggins test.</u> Vaccination records are required, dated within six (6) months prior to the date of show. Do not submit your Coggins Test Certificate and vaccination records with your entry form. Keep these items in your possession and present them at check-in. Show management reserves the right to randomly check health papers.

#### **JUDGES**

It is a violation of AHA rules to commit any act or make any remark during the show that is considered offensive or intended to influence or cast aspersions on the judging. Exhibitors shall not have contact with a show judge, or approach a judge regarding a decision, unless accompanied by a member of Show Management. If any judge or other show official designated in this prize list is unable to perform their duties, Show Management reserves the right to substitute the individual according to USEF rules.

#### **PROTECTIVE HEADGEAR**

At Federation licensed and endorsed Events, Athletes must wear headgear as follows, except as may otherwise be mandated by local law (see also GR801) b. Upon arrival, anyone riding a Horse must wear properly fitting protective headgear. The harness must be secured and properly fitted. See GR801.

#### **PROTESTS**

Any protest must be made in accordance with the AHA Code of Ethics and Sportsmanship (see ETHICS 108).

#### **SHOEING REGULATIONS**

Refer to the 2024 AHA Value Show Rules & Regulations (see SHOW 120).

#### **VETERINARIAN INSPECTIONS**

At the discretion of Show Management, all horses are subject to inspection by the show veterinarian for the use of mydriatic drugs, or if suspected not to be serviceably sound. All decisions of the show veterinarian shall be final and may not be contradicted by another veterinarian used by the exhibitor (also see Health Certifications under RULES & REGULATIONS.

#### **WHIPS**

Each handler may use only one whip (not to exceed 6' in length including snapper/lash/appendage) inside or outside the ring while showing a horse. A small appendage (ribbon, plastic, etc. less than 12 inches long) is permitted. Harness classes are excepted. Excessive or improper use of a whip shall be cause for disqualification.

#### **USEF Motorized Vehicle Statement**

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

I AGREE that I choose to participate voluntarily in this Competition, as a rider, driver, handler, leasee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor. I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN AND SUFFERING, AND PROPERTY DAMAGE. #### Directions:

Address: Longview Horse Park, 12600 SE Raytown Rd, Grandview, MO 64149

**From I-70:** Route 470/291 south to 470 west, exit at Raytown Road, South to Highgrove Road. Left to 4-way stop, also Raytown Road. Left to Horse Park Driveway (approx 1 mile on right).

**From West:** Route 435 East then follow Route 470 East to Raytown Road South then as above. North: Route 435 South (east side of KC) to 470 East to Raytown Road South then as above.

**From South:** 71 Highway to Grandview, MO - Main Street Exit. East for 2.6 miles to second 4-way stop. Left at second Raytown Road. Left to Horse Park Driveway (approx 1 mile on right).
