- Enhanced packaging and custom marketing provided
- You keep 50% of the final sale price

- d. Compliance: The Consignor agrees that all items consigned comply with all applicable local, state, and federal laws. Any violation is the sole responsibility of the Consignor.
- e. Dispute Resolution: Any dispute arising from this agreement will first be attempted to be resolved through informal communication. If unresolved, both parties agree to binding arbitration in the jurisdiction of Not Heads' principal business location.
- f. Verification: By signing this agreement, the Consignor confirms the accuracy of the information provided
