# Meet our Director



## Jenn Noon

Noon begins her 11th year as owner and Camp Director of Competitor's Edge Field Hockey. Noon is currently the Director of Athletics at Fairleigh Dickinson University's Florham Campus. Noon spent 9 seasons as the Head Coach at FDU. Noon's relentless energy and extensive knowledge of the game, accompanied by her USA Level I and II Field Hockey Coaching Accreditation have contributed to her success as head coach at FDU. She was

named Freedom Conference Coach of the Year for the past three seasons following her team's sensational run in post season. Her first coach of the year nod came following the 2011 season, in which the Devils captured the Freedom Conference Regular Season Championship. Noon has led her team to the most decorated season to date with a MAC Freedom Conference Championship, a first round NCAA win and a "Sweet Sixteen" Appearance in 2014. Noon has taken the team to the Conference Finals, four times in seven years, and a post season Championship game seven times. She serves on the NCAA Division III Field Hockey Committee, the NCAA All-American Selection Committee, the NCAA Coach of the Year Selection Committee, and the ECAC Championship Selection Committee. Most recently, Noon received the Division III Transitioning Athletic Administrator Award, along with the 2015 FDU Pinnacle Award. A standout field hockey player at Rutgers University, Noon was a four time letter winner and was named First Team All-Big East in 2003. She was also a three time All-Academic player, a member of the National Academic Team, Big East Offensive Player of the Week, and a recipient of the field hockey team's "Mission Statement Award." Noon currently is a member of USA Field Hockey, the NFHCA, and a proud member of NACWAA.

A \$40.00 processing fee is non-refundable under any circumstance including the cancellation of camp due to a pandemic. The reservation deposit is non-refundable and non-transferable after July 1, 2022. Application deadline is July 10, 2022.

## Cost / Sessions

**Commuter: \$420.00**

**2022 Payment Policy:** A \$200.00 deposit is required with application. Full payment must be received by June 1, 2022. A late fee of \$25.00 will be assessed if payment is received after June 1, 2022. We will not accept payment by personal check 14 days prior to the start of your selected camp session. **If applying after May 15, 2022, please submit full payment with application.**

**2022 Refund Policy:** Reservation deposit is non-refundable after July 1, 2022. A \$40 processing fee is non-refundable under any circumstance including the cancellation of camp due to a pandemic. **No refunds will be given five business days prior to the start of your selected camp session.**

## Early Registration Discounts

**Individual Discounts:** Available for all campers when registration is received by February 1st and receive a \$25 discount.

**Team Discounts:** Available for resident campers with 12 or more from the same school attending the same week. Team applications with deposits must be submitted in one envelope as a team by the coach or designated representative. Subsequent additions to the roster will not be eligible for discounts. Register as a team before March 1, 2022 and receive a \$25 discount per camper.

**NOTE:** Individual and Team discounts can be combined if payment and registration is received by February 1st.
