I, _____, am applying for membership to the Caney Golf Club. If accepted, the membership is subject to the rules and regulations adopted by the members and Board of Directors of the Club. Special consideration should be given to the rules and regulations concerning payment of dues and charges, suspension and termination of membership. A \$100 initiation fee is required for new memberships and termination reinstatement. Cost of general membership is \$70 per month - or \$840 per year. There is an annual \$35 clubhouse special assessment to subsidize the cost of keeping the clubhouse/concession area open.

SPECIAL 49% DISCOUNT FOR PREPAID FIRST-TIME MEMBERSHIPS: The new membership initiation and special assessment fees will be temporarily waived for an introductory 12-month rate of \$500 if paid in advance. If you prefer \$50 monthly installments, you still save 38%. After 12 months, the general membership rate and clubhouse assessment go into effect. **Payment must accompany completed application.**

Indicate payment option. ___ \$500 full-year membership dues OR ___ \$50 check for first monthly installment.

FORMER MEMBER REINSTATEMENT: **More than 12 months but less than 3 years** complete this application and including a check for the \$170, which includes a \$100 reinstatement fee and first month's \$70 membership fee. The \$35 annual clubhouse assessment will be collected with your second month's payment. **More than 3 years after lapsing in good standing** eligible for the new-member discounted rate described above in the "Special 49% discount for prepaid first-time memberships" offer. SUBMIT COMPLETED APPLICATION: Place completed form and attached check in the green mailbox pipe on the clubhouse porch – or mail to PO Box 263, Caney, KS 67333. You will receive a statement the first of each month, payable on or before the 15th. You will be notified by phone and/or email if your membership has been accepted.

Caney Golf Club membership entitles the member and their immediate family to full privileges at the Club. The following persons shall be deemed immediate family: the member's spouse, children living at the family residence who are not over 21 years of age, if not a student, and not over 24 years of age if a full-time student at a college or technical school.

Members may bring lineal relatives to the course at a rate of \$5 per 18-hole round or \$10 unlimited golf per day. Lineal relatives include parents, grandparents, brothers, sisters, grandchildren, mother- and father-in-law and son- and daughter-in-law. **The member must be with the relative during play.**
