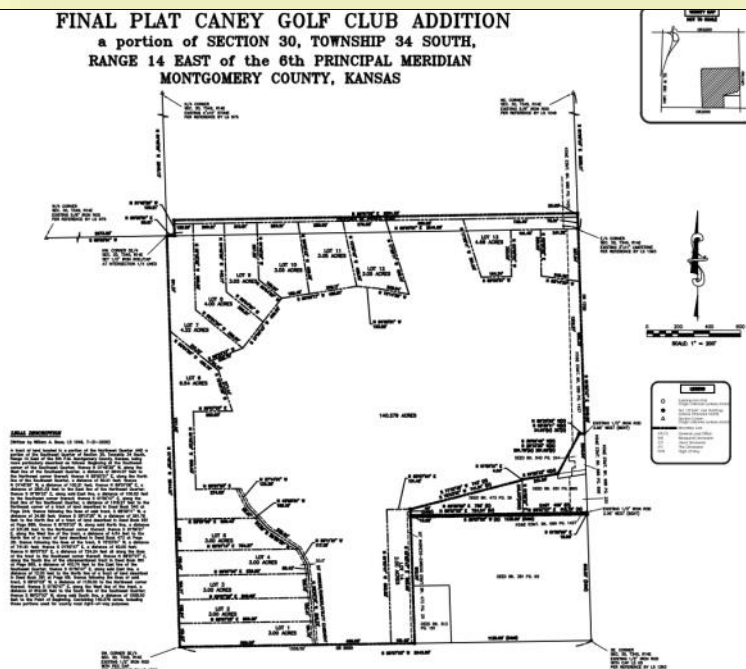
Brandon Montgomery will assemble a tournament committee in January 2021. Why join?

## Holding funds for lots of costs

The Club reported a \$1,546 September loss after paying surveying and partial attorney fees for a land purchase contract in pursuit of future residential lost sales. Through the first three quarters, net income was \$30,773, which included more than \$18,000 in green fees and cart rentals.

The club is holding the funds rather than paying off loans for liquidity to purchase land and meet future development costs such as fencing, acreage and road construction.
