We are Tubu or Toubou people we have owne civilization for example language of Tubu (Tudaga is isalat language) we have owne law (not islamic law), owne morality code (KUNDUDO) .

Toumaghra has Founded Kanem Empire the Kanem Empire from the 8th century AD onward and lasted as the independent kingdom (the Bornu Empire) after 14th century capital transfer to Zouar (Tibesti) forbidden to foreigners until 1866 Gustav Nachtigal (Spy and Medical-Doctor) sent by Otto von Bismarck is the first European to arrived in Tibesti.

This NGO is dedicated to actions promoting peace and progress in Tibesti, integration of Tubu in Southern Libya and northern Chad, as well as demining of this region. I am the author, first complaint against Gaddafi for crimes against humanity at the International Criminal Court in The Hague, on September 14, 2009, as well as the initiator of the "Non Khadafi" ("No Gaddafi") campaign in the European countries and the African Union with the distribution of more than 2000 leaflets in Addis Ababa in 2010, between 2003-2011. I am on Gaddafi's hit list. NGO TIBESTI is a very active organization. We set up an anti-Gaddafi website [www.tibesti.org](http://www.tibesti.org), a big data more information [tibesti.org](http://tibesti.org) on crimes of Gaddafi, our web site was destroyed in October 2010. I'm doing a photo exhibition telling life in Tibesti. In the area of Kuri Bogodi we found a lot of gold. From 12 March to 12 April 2010, INALCO (National Institute for Oriental Languages and Civilizations), the staff of embassies in the United States in Paris and other countries, embassies of Africa countries went to visit the exhibition.

Since 2002, we mentioned on our website [tibesti.org](http://tibesti.org) that we have a lot of gold everywhere in Tibesti. For this reason, Gaddafi put anti-personnel mines.

Exhibition from January 28, 2011, to March 28, 2011, was frequently visited by INALCO (National Institute for Oriental Languages and Civilizations).
