- 4 officer meetings
- 1 annual meeting (can be one of 3 member meetings)

>> Submit CPEs on behalf of members

>> Submit annual report by January 31st

Mentorship Program

- The program aims to offer prospective security professionals with guidance from seasoned security professionals.
- To gauge interest on the mentor's side, a survey was developed and shared with the chapter members
- Preparations will continue in 2022





Community Outreach

We conducted outreach activities to help

- >> Grow membership
- >> Support chapter activities (programming)

Through this, we established communication with about 10 organizations. This created awareness that a chapter is active in Montreal

We also had a membership drive through (ISC)2 to increase membership.





Membership Goal for 2021

- >> Our goal in January 2021 was to double our membership throughout the year
- >> In January 2021, we had a total of 17 members
- >> In December 2021, we reached a total of 35 members
- >> Our membership consists of both certified and non-certified (ISC)2 security professionals. This also includes a small number of students

>> Additional in person activities if possible (networking, etc.)

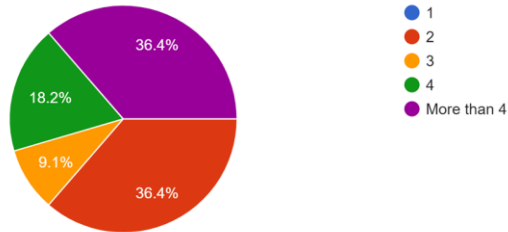

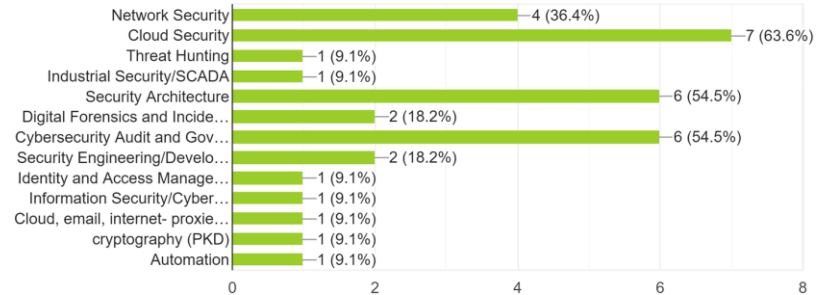
Mentorship Program
