

## **TCE SETTLEMENT AGREEMENT**

This TCE Settlement Agreement is entered into as of this \_\_\_\_ day of the month of \_\_\_\_\_, in the year of \_\_\_\_\_ by and between \_\_\_\_\_, (Party A) an individual with SSN \_\_\_\_\_, and *The Credit Empire Company, Inc.* (Party B) a credit repair and debt management company, operating under the laws of Alabama, USA.

### **RECITALS**

WHEREAS, the Parties have had certain disputes arising out of disagreement of payment amount;

WHEREAS, the Parties wish to resolve these disputes amicably and avoid further legal actions;

NOW, THEREFORE, in consideration of the mutual covenants and promises contained herein, the Parties agree as follows:

### **SETTLEMENT AMOUNT**

Party A agrees to pay Party B 10% (ten percent) as full and final settlement of all claims arising out of the aforementioned disputes.

### **PAYMENT TERMS**

The Settlement Amount shall be paid by Party A to Party B within 1 day from the Date that Settlement Check is released into Party A's possession.

### **RELEASE OF LIABILITY**

Upon receipt of the Settlement Amount, Party B releases and forever discharges Party A settled account.

### **DATA PRIVACY**

- a. Both Parties agree to comply with all applicable data protection and privacy laws and regulations.
- b. Any personal data shared between the Parties shall be processed solely for the purposes of this Agreement and shall not be disclosed to any third party without the express written consent of the data subject.
- c. Both Parties shall take appropriate technical and organisational measures to protect personal data against unauthorised access, loss, or damage.

## **CONFIDENTIALITY**

The terms of this Agreement and any information exchanged pursuant to this Agreement shall remain confidential and shall not be disclosed to any third party without the prior written consent of the other Party, except as required by law.

## **GOVERNING LAW**

This Agreement shall be governed by and construed in accordance with the laws of Alabama, without regard to its conflict of laws principles.

## **DISPUTE RESOLUTION**

Any disputes arising out of or in connection with this Agreement shall be resolved through amicable negotiations between the Parties. If the Parties are unable to resolve the dispute within 30 days, it shall be referred to and finally resolved by arbitration in the state of Alabama.

## **ENTIRE AGREEMENT**

This Agreement constitutes the entire agreement between the Parties and supersedes all prior negotiations, understandings, and agreements, whether written or oral, relating to the subject matter of this Agreement.

## **AMENDMENTS**

Any changes to this Agreement must be in writing and signed by both Parties.
