## A New Era in Digital Fundraising

The National Office of Development is thrilled to announce a game-changing upgrade to our fundraising toolkit: Scouting America is partnering with Bonterra to adopt EveryAction as our official online donation platform, nationally and for local councils. This decision comes after more than a year of thoughtful research, product demos, expert insights, feedback from Scout executives and development directors, and careful budget planning. We are currently rolling out the platform with select Alpha Test councils to ensure a smooth transition. A broader Beta Test will follow this summer, and our goal is a full national launch by *September 2025*. On *Thursday, May 15 at 1:00 PM Eastern* there will be a breakout session and demo at the National Annual Meeting. Bonterra will also have a booth at the meeting.

## **Updated Crew Officer Seminar Training**

The National Venturing Committee and Scouting U have announced the release of the updated *Crew Officer Seminar*, also known as the Planning Session, which builds on information from *Crew Officer Orientation*. This training allows the crew to understand and create their annual program. The training will cover the three Tiers of Adventures, review the Venturing ALPS model, explore recruitment ideas, and walk through the steps of planning for an event or activity. It is strongly recommended all crews complete this training annually, ensuring that every member has a clear understanding of planning their annual calendar and is expected to be taken by crew officers. This updated training replaces the previous online version hosted on the Volunteer Learn Center. It is now brief, engaging, and interactive, and is intended to be delivered in-person by crew officers during crew meetings. You can access the *Facilitator's Guide* here.

#### **Council Commissioner Confab**

Council and territory commissioners - check your email for an invitation to the *May 4* Council Commissioner Confab. We have been hearing a lot of questions about changes to how we serve units and the updates to Commissioner Tools that support this shift. This session will cover the most frequently asked questions, followed by breakout discussions to explore other areas where more information is needed.

## **Supply Chain Issues**

From Roger Krone - As you are likely aware, global retailers and organizations across industries are currently facing significant challenges related to the evolving tariff landscape. These impacts stem from a variety of geopolitical, economic, and regulatory changes, and are creating widespread strain on production timelines, sourcing strategies, and pricing structures.

For our organization, the implications are particularly meaningful. The products we provide directly support the youth who participate in our programs—and ensuring access to safe, high-quality, and ethically made products remains central to our mission.

As such, we want to inform you that we will soon begin to experience service disruptions in product delivery and potential impacts on pricing. While we are working tirelessly to minimize these effects, the reality of shifting tariffs and supply chain instability means that short-term interruptions are likely.

Please know that mitigating pricing impacts is our highest priority. Our Product Merchandising vendors are actively relocating production to qualified factories that can support our needs and help stabilize costs. However, we want to be crystal clear: any product bearing the Scouting America brand must continue to meet our strict social compliance standards. Every factory must pass our social compliance audits. This is critical to maintaining the safety and integrity of our brand and upholding our commitment to ethical production.

As we manage these fast-paced transitions, we urge all councils to be prepared for temporary delays and adjustments in not only stocked product but in customized products produced through our licensed partners. It is imperative that you continue to work only with authorized, licensed vendors. This is a non-negotiable policy. These protocols are in place to protect our Scouts, our brand, and each of you as valued partners.

We appreciate your understanding, patience, and partnership as we navigate these temporary challenges together. Your adherence to our standards ensures we emerge stronger, more aligned, and more resilient.
