How do I know if I am 100% P&T?

A veteran can be rated 100% "Total" without being "Permanent".
This usually happens when VA assumes a disability may improve.

You can tell if a 100% award is Permanent and Total (P&T) as the decision will approve "Dependents Educational Assistance" and "Chapter 35 Benefits".

If you are still unsure, Lancaster County VA will be able to verify.
