

## Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://samlaflammephotography.com> and Sam La Flamme Photography and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Sam La Flamme Photography include <https://samlaflammephotography.com> and La Flamme Boudoir. The La Flamme Boudoir website is a Photography site. By using the La Flamme Boudoir website, you consent to the data practices described in this statement.

### Collection of your Personal Information

In order to better provide you with products and services offered on our Site, La Flamme Boudoir may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

La Flamme Boudoir may also collect anonymous demographic information, which is not unique to you, such as your:

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
