

# 2026 Skunk Works® Golf League

## Rancho Vista and Antelope Valley Country Club

The 2026 Skunk Works® Golf League will begin on Tuesday April 28, 2026. It will last approximately 16 weeks. The league will play on Tuesday's and Wednesday's and will alternate week play between Rancho Vista G. C. and the Antelope Valley C. C. There is room for a maximum of 24 teams (48 players) and an unlimited number of substitutes. The format will be two-man teams in a Ryder Cup match play style team head to head for points. A non-refundable fee of \$70 per player is necessary to secure your spot in the league. The fees will cover closest to the pin on each par 3 throughout the season, prizes for mini tournaments, administrative costs, trophies, and the awards luncheon at the end of the season. Although substitutes need not pay the \$70 entry fee, they are required to fill out this application. More information can be found at the league website at <http://www.skunksgolf.com>. The league website will be the sole source of league updates.

Employees and retirees, as well as their insured spouses, sons or daughters (with parents' consent if minor) are eligible to participate. In addition, Contractors and Customers working with Lockheed Martin are also eligible.
