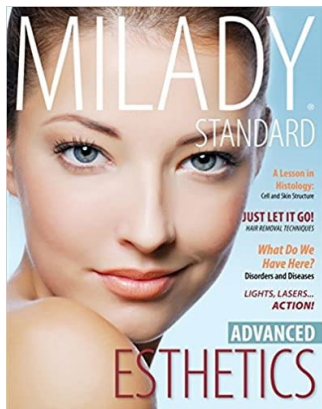


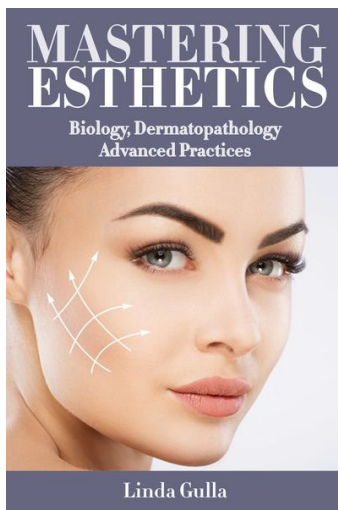
Esthetic Field

That was a huge moment in her career where she realized the need for a unilateral educational platform in cosmetic medicine bridging all levels of practice.

In the medical field, her company *International Academy of Cosmetic Laser Surgery* has been approved by the *American Academy of Family Physicians* as an educational provider. As a Plaintiff expert, Linda has worked with malpractice attorneys in file review, paralegal services, and has testified as an expert in jury trials. As of 2024, Linda continues to offer her expertise in cosmetic laser litigation and is a member of the Expert Institute of NYC and has worked as an expert with Cahn Litigation Services and Homestead Medical Experts.

After reviewing numerous cases of malpractice, Linda saw the need for further instruction within the cosmetic laser discipline and was determined to create a scholarly based laser and IPL training course for medical practitioners and estheticians. In 2021, she founded the *International Academy of Cosmetic Laser Surgery* which initiated a laser training program bridging multi-level practitioners in cosmetic laser science and safety regulations. Her laser program has been approved as a prerequisite by the Board of Laser Safety and meets the highest standards nationally for Certified Medical Laser Safety Officer credentialing.

Professional Aspirations

Linda continues to offer professionals the latest research in medical aesthetics through her company, *Institute of Advanced Aesthetics and Health Sciences*, which offers a medical aesthetic training program to estheticians, nurse practitioners and paramedical professionals. Her platform offers online education as well as print material and correspondence learning material.

Through her company *International Academy of Cosmetic Laser Surgery*, Linda provides medical spas and laser clinics with qualified Medical Laser Safety Officers who are eligible for the *Board of Laser Safety* CMLSO credentialing.
