

# Exhibition Barrels 15 & Under Competitor GOLD DUST RODEO

June 23 – 24, 2023

Exhibition Barrels will be both nights starting right after the barrels (subject to change based on rodeo needs). It is open to any child 15 or younger as of January 1st, approved by the Gold Dust Arena Committee (GDAC.) **Long sleeved shirts, jeans, hat and boots are required (if you show up without the proper attire you will not be allowed to ride).** The entry fee is \$25 per entry per day, limited to one run per night. This application must be received on or before June 18, 2023. We will accept the first paid 12 entries received per night. Check in time is from 6:00 to 7:00 pm the night of the performance. If participants have not checked in by 7:00 pm the night of the performance, it will be filled by first come first serve that night. Gold Dust Committee members have the right to turn out any competitor in the event of confrontation or for safety reasons with no refund given. Each paid competitor will receive Rodeo admission along with admission for one parent/companion. A buckle will be awarded to the 1<sup>st</sup> place winner with the highest race time after all runs are completed. If a competitor enters more than once, 1<sup>st</sup> run time is the time recognized for placing purposes.
