Annual Membership Agreements

Corporate Membership

The Corporate Membership will be owned by the purchasing corporate company. They may assign any employee of the corporation as the designated corporate member while visiting the lodge. There must be a corporate designee present anytime that they have the attendance of employees or guest. Multiple corporate employees may come to the lodge and have full benefits of all of the lodge's amenities at the assigned rate for the Corporate Membership. A Corporate Member, Corporate Employees, and/or Guests would be allowed to come to the lodge at any time they would like (reservations required)^{***}. Corporate members are allowed to have a maximum of 15* overnight employees and/or guest combined. Daily guest numbers over 15 must be pre-approved by Bayshore Lodge and only available for Corporate Membership. A daily rate of \$25.00 per guest is required for day visits and activities. Corporate Membership owners or their designated corporate member must acknowledge and abide by the Bayshore Lodge, LLC, Legal Disclaimer.

Individual Membership

The individual membership will include one (1) person. This person is allowed to come to the lodge anytime that they would like (reservations required)^{***}. They would have full benefits of all of the lodge's amenities. The Individual Member would also have the opportunity to bring up to 3* guest at the assigned rate for them and guest as described for the Individual Membership. The member must be present anytime that they have the attendance of guests. There are no shared Individual Memberships. Individual Membership owners must acknowledge and abide by the Bayshore Lodge, LLC, Legal Disclaimer.

Family Membership

The Family Membership will include family members, as described below. It will require a responsible person of the family, older than 25 to be a designated as Family Member. The designated Family member is allowed to come to the lodge anytime that they would like (reservations required)^{***}. They would have full benefits of all of the lodge's amenities. The Family Member would also have the opportunity to bring up to 4* family members and/or guest at the assigned rate for themselves and guests as described for the Family Membership. The designated family member must be present anytime that they have the attendance of family or guests. Individual Membership owners must acknowledge and abide by the Bayshore Lodge, LLC, Legal Disclaimer.

**Additional guest may be allowed providing there is room, prior arrangement must be made.*

***A family is defined as a maximum of two adults and their dependents, ages 25 years or younger, who are permanent residents of the same household.*

****A Maximum of 7 consecutive nights allowed unless prior approval by Bayshore Lodge.*
