Attend the National Disaster Resilience Council (NDRC) Workshop and Summit, November 20-21

At the workshop, speakers including William Terry Boston, National Infrastructure Advisory Council, Aaron Shaw, Chair of the NERC EMP Task Force, Ian Grant, TVA, and Kyle Thomas of Dominion Virginia Power. John Heltzel, EIS Council, will discuss EarthEX and Ambassador James Woolsey and Major David Stuckenberg will present the results of the Electromagnetic Defense Task Force April event. Rob Hartwell will discuss how to effectively present information to Congress at the national and state level. The follow-on panel will discuss resilience, and then attendees will participate in discussing needed exercises, how to provide information to Congress, predictive modeling and other critical internal NDRC items.

At the following day Summit, Speakers will include Senator Ron Johnson, Chairman of the Homeland Security and Governmental Affairs Committee and Mark Harvey, Special Assistant to the President and Senior Director for Resilience Policy on the National Security Council Staff. Additionally, five (5)

representatives from Idaho National Laboratory will discuss their testing and we will learn about new technologies including two pilot projects.
