- 2. That the Vendee with his own expenses shall get transferred/mutated the **Said Property** under sale in their favour in the records of the Municipal Authorities/
 Developer of any other Government department concerned on the basis of this
 Sale Deed even in the absence of the Vendor who shall have no objection in this
 regard and will also extend full cooperation to the Vendee when asked for in this
 regard.

- 3. That all the taxes, or any other Government or municipal dues and demands including external development charges payable to Haryana Govt. and/ or other authorities in respect of the above mentioned property under sale up to the date of registration of this sale deed shall be borne and paid by the Vendor and thereafter the same shall be paid by the Vendee.
- 4. That the Vendee shall realize all the rents and profits of the **Said Property** from the date of registration of this Sale Deed and the Vendor shall not demand any amount from the Vendee hereinafter.
