

## DBS Updates

The number of DBS applications have increased significantly over the last few months now things are beginning to get back to 'normal', which is great news. To assist with the timely process of DBS applications just a gentle reminder that Non UK birth and marriage certificates (including Irish), NHS medical card, mobile phone bills, National Insurance card, TV licence, vehicle registration document, and payslips are not accepted by DBS. If you are not sure whether a document is eligible then it is best to contact the office before sending it in or refer to the DBS3a Guidance notes which are available to download from the diocesan website
