

# **Terms of Business / Allplan**

These Terms of Business are between Rossi Concepts and its Client for each time Rossi Concepts provides the solution Allplan to a Client (You).

#### 1 Software Licence

Rossi Concepts has been provided with a licence by Allplan Deutschland GmbH GmbH, to distribute the software solution Allplan (Software) in Australia and also to provide services in relation to Allplan. The terms for granted Allplan Licences are set out in an EULA (End User Licence Agreement) by the supplier direct and are made available on the Allplan website  $\underline{www.allplan.com}$  or when you download the Allplan Software. The EULA is applicable to all Allplan items set out in Your attached quotation. Where the EULA and this terms are inconsistent, this agreement will prevail. Allplan Deutschland GmbH GmbH is entitled to all the rights attached to the Alplan licensor (where appropriate) or similar under the EULA. Subject to this terms and conditions and conditions of EULA (End User Licence Agreement), is that the Allplan Deutschland GmbH GmbH grants You a limited, non sublicensable, non exclusive, non transferable right to use the Software in the manner and for the purpose described. The Documentation shall include, but not be limited to, any printed materials or electronic data provided by or obtained by Allplan Deutschland GmbH GmbH with regard to the software solution Allplan.

## 2. Software Service Agreement (SSA)

Rossi Concepts provides a Allplan Software Service Agreement for perpetual licences, which includes Support (Phone & Online), Upgrades. Die SSA is available for existing and new customers. New Line-Up packages and latest Allplan version are mandatory. The SSA fee is invoiced once a year, for 12 months in advance with Auto-Renewal. The termination must be done min. 3 month before end of actually invoiced SSA period. Specific terms apply for START Up Offers: The min. duration is here 24 months – after 24 months the regular SSA amount will be charged. Rossi Concepts is not liable to You for any loss or damages caused by a breach of the Software Service Agreement, for delayed Services.

## 3. Subscription based Licencing

The duration of Subscription periods is 1, 2 or 3 years, with Auto Renewal to the next 1, 2 or 3 years until Subscription will be terminated. The Subscription is invoiced once for 1,2 or 3 years in advance. Subscription fees containing also Update and Upgrade to the newest version of Allplan during the entire subscription period. Specific terms apply for START Up Offers: Max 3 years in total possible, extension has to be ordered for each of the 3 years, 2 months before end of the current period. After the 3 years the regular subscription fee will apply.

## 3. Rental Licences

Minimal duration of the rental period are 3 months – maximum duration 12 months. The total amount of the chosen term will be invoiced in once upfront.

## 4. Ownership Rights

All rights, title and interest in and to all copyrights, patents, trade secret rights, trademarks and other intellectual property rights in and to Allplan, are owned by Allplan Deutschland GmbH Gmbh.

## 5. Restrictions

You may not rent, lease, sublicence, loan or resell Allplan to third parties. You may not permit any third parties to benefit from the use of Allplan. You may not duplicate or copy any portion of Allplan, unless otherwise set forth herein. All rights not expressly set forth hereunder are reserved by Allplan Deutschland GmbH GmbH.

#### 6. Rossi Concepts - Reseller

Rossi Concepts is an authorized reseller for Allplan in Australia. As such Rossi Concepts is no affiliated with Allplan in any capacity other than as distributor, installer or consultant of Allplan products and has no authority to modify any Alplan licence or warranty.

#### 7. Refund and Replacement Policy

In accordance with the Australian Consumer Law, where the Software purchased has a major failure, You are entitled to a replacement, refund, repair or compensation for the drop in value if a major failure occurs. Major failures are described in the Australian Consumer Law. Neither Rossi Concepts nor Allplan Deutschland GmbH is required to provide a refund if You simply change your mind.

#### 8. Invoice & Payment

After Rossi Concepts has received the signed proposal an invoice is sent. The payment is due immediately or otherwise if stated in the invoice. Delivery of services or software will take part once Rossi Concepts has received payment or in urgent cases remittance of bank transfer has been provided as proof of payment. In the event that you have a monthly payment and you fail to pay the amount as and when due, Rossi Concepts reserves the right to charge interest on any outstanding amount at the rate of 0.05% per day.
