CHARGES: Fee for gym rental will be \$100.00 per hour. Rental rates from 4-8 hours will be a total of \$400.00. A non-refundable deposit of \$100.00 is due at the signing of the contract. The deposit will also be non-refundable if the facility is damaged, left uncleaned, no show or cancellation. The deposit will be refunded after inspection of the premises. Rental events exceeding the agreed upon hours will be assessed an additional \$100 per hour.

AGREEMENT: I understand that participation in this facility, <u>SPAULDING FAMILY</u> <u>RESOURCE CENTER, INC. ("SFRC"), at 600 South Pine Street, Spring Hope, NC, will be released from ALL liabilities and responsibilities.</u> Enjoy the facility at your own risk.

GYMNASIUM GUIDELINES

- 1. NO weapons or firearms on premises.
- 2. NO alcohol is allowed on premises.
- 3. Smoking is *NOT* permitted in the building at any time.
- **4**. Lighted Candles are *NOT* permitted in the building at any time.
- **5.** All decorations, supplies, flowers, and accessories must be promptly removed following the event. *NO* stapling, nailing, gluing, taping, etc. to the walls.
- **6.** *SFRC will not* assume any responsibility for items left by the guest or renter.
- **7.** *SFRC will not* sign for, take possession of, or assume responsibility for any deliveries.
- **8.** *SFRC's* staff *will* be responsible for opening and closing facility.
- **9.** *SFRC* reserves the right to decline any application.
- **10.** *SFRC* retains the right to ask the renter or anyone from the renter's function to leave the building for misconduct. *NO* fighting, unruly conduct, profanity, inappropriate music, rough play, disorderly conduct. Additional sanctions may apply.
- 11. DO NOT play on or open the bleachers, without prior permission or authorization from SFRC.
- **12.** Pets are *NOT* allowed. Service animals may be denied access to the facility if there is a threat to the health or safety of others.
- 13. I agree to indemnify and hold SFRC harmless from and against any and all claims and demands which may arise as a result of SFRC granting permission to me to enter into a Rental Agreement for use of the Gymnasium, including but not limited to all claims and demands for personal injury, death, or damage to property sustained by any person, firm or corporation, together with all cost and reasonable attorney's fees for defending same.
