She also reported GSO's quarterly reports from the fourth quarter of 2023 (District 13 contributed \$1,564.86; \$3,093.52 for the entire year) and the first quarter of 2024 (District 13 contributed \$509.17).

Lori reported continuing to work the Area Registrar to make sure all groups are both registered with GSO and listed on the Minnesota Meeting Finder. She prepared and distributed a spreadsheet of meetings at the seven Alano Clubs in District 13. Most of her outreach has been on these meetings, and she plans to focus on meetings held outside of Alano clubs during the remaining of her term. There are 20 cities in District 13; Lori has a list of 24 meetings she will attempt to visit. Lori asked if anyone took the Box 459 survey emailed out. Box 459 is the quarterly report about news and notes from the General Service Office. She highlighted the Winter edition that included announcing two new staff members - Kelley C. - Treatment/Accessibilities and Rainer L. - Corrections. The Grapevine released a new softcover book entitled. "Our Twelve Steps." The 2025 International Convention is in Vancouver, British Columbia, July 3-6, 2025. The 2030 IC will be held in St. Louis, MO, and the 100th Anniversary of AA in 2035 will be held in Indianapolis, IN July 4-7, 2035. Attendance for 2025 is expected at 45,000+. Lori attended the Area Committee Meeting May 4th. Discussions during the DCM Sharing included whether our districts have completed an Inventory, what functions our districts do to get groups involved, do districts have a budget, and do districts host our Delegate for a report back (when and where). Does the district want us to conduct an Inventory? A couple districts do this, but it might be more beneficial to just take a personal inventory and read a word about commitment. It is the responsibility of the Alt DCM to host workshops and we don't have one. We do have our Gratitude Celebration and now a potluck for the Delegate's Report Back. Some districts do an annual picnic or holiday party and miscellaneous workshops. With regard to the budget, we are good asking for committee input and presenting it before year end. A lot of districts do host the Delegate. The afternoon consisted of officer and committee chair reports. Our Delegate, Meg, reported that the manuscript for the plain language (a tool to read the A.A. Big Book) was approved! We have a new West Central Regional Trustee – Charlie H., who was picked from the hat. He is from Area 41 – Nebraska. Contributions to Area 36 are down as compared to last year at this time. The PI Chair will be sending out an email to all DCMs about volunteering to be a day captain for the Minnesota State Fair, which means that day is filled with volunteers from District 13. If District 13 is interested, please let her know. We will revisit this next month.
