## \$50.00 HEAT SURCHARGE

THIS CHARGE WILL BE APPLIED TO THE MONTHLY STATEMENT DURING THE WINTER MONTHS. IN ADDITION, DURING PERIODS OF EXTREME COLD WHEN THE AVERAGE FUEL USAGE EXCEEDS NORMAL LEVELS, THE OVERAGE WILL BE DIVIDED BETWEEN ALL TRAINING/BOARDING CLIENTS FOR THAT MONTH.

## BILLING STATEMENT:

WHEN ENTERING OUR TRAINING PROGRAM, THE INITIAL FEES ARE TO BE PAID IN FULL UPON ARRIVAL.

MONTHLY STATEMENTS WILL BE EMAILED AND OR SENT BY PAPER BILLING APPROXIMATELY 10 DAYS BEFORE THE DUE DATE. THE DUE DATE IS THE FIRST OF EACH MONTH. ANY PAYMENT ON ACCOUNTS RECEIVED AFTER THE 5<sup>TH</sup> OF THE MONTH AFTER THE 1<sup>ST</sup> ARE CONSIDERED LATE AND WILL BE CHARGED \$45.00 PER DAY UNTIL THE ACCOUNT IS PAID IN FULL.

ALL STATEMENTS ARE SENT VIA EMAIL THROUGH AN ACCOUNTING SITE CALLED AYNAX. BE SURE TO LOOK INTO YOUR SPAM AND JUNK MAIL IF YOU FEEL YOU AREN'T RECEIVING YOUR INVOICE. AFTER 5 DAYS LATE ON PAYMENT OF YOUR STATEMENT, YOU WILL MOST LIKELY RECEIVE A LATE NOTICE VIA AYNAX. WE HOPE THAT YOU WILL REMIT YOUR STATEMENT PAYMENT PROMPTLY IN FULL AT THE APPROPRIATE DATE. IF THERE IS A SITUATION THAT ARISES THAT YOU BELIEVE WILL RESULT IN BEING LATE ON YOUR STATEMENT, PLEASE LET US KNOW AND WE WILL BE MORE THAN HAPPY TO HELP MAKE OTHER ARRANGEMENTS.

ALL ACCOUNTS MUST BE PAID IN FULL BEFORE REMOVING AN ANIMAL FROM OUR CARE.

WE UNDERSTAND THAT THERE ARE TIMES WHEN INJURIES OCCUR, FAMILIES GO ON VACATION, OR THINGS JUST AREN'T MATCHING UP FINANCIALLY. WHEN THERE IS A

NEED TO PUT YOUR HORSE ON BOARD, BUT NOT TO STAND FOR AN EXTENDED LENGTH OF TIME, THIS OPTION IS AVAILABLE.

## BOARD:

\$550.00 PER MONTH

INCLUDES GRAIN & HAY, STALL CLEANING

WE ARE NOT A BOARDING FACILITY. HOWEVER, CERTAIN ARRANGEMENTS CAN BE MADE IN CERTAIN CASES WHERE A BOARDING SITUATION WORKS WITHIN THE PROGRAM. THIS OPTION IS MADE ONLY BY OUR DISCRETION. IT IS NOT READILY OFFERED ON A REGULAR BASIS, ONLY IN RARE SITUATIONS.

PLEASE NOTE THAT ANY BOARDING SITUATION PLACES YOU IN A NON-TRAINING STATUS IN REGARD TO LESSON AND SHOW RATES.

## SHOW RATES / DAY FEES:

DAY FEES ARE LISTED AS “ SHOW DAYS” AND “NON/SHOW DAYS”

THESE CHARGES APPLY TO ALL SHOWS WITH THE EXCEPTION OF THE CONGRESS, WORLD SHOWS AND NOVICE CHAMPIONSHIPS

TRAVEL/NON-SHOWING DAYS- \$35.00 PER DAY

SHOW DAYS - \$50.00 PER DAY

FOR CONGRESS, WORLD SHOW AND NOVICE CHAMPIONSHIPS:

FLAT RATE -\$400.00 PER HORSE.

THERE WILL BE A \$45.00 PER DAY MEAL ALLOWANCE PER TRAINER, ASSISTANT TRAINER, AND OR ADDITIONAL HELP HIRED FOR THE CONGRESS, WORLD SHOW, LEVEL 1, ETC.

- ADDITIONAL LABOR IN MOST CASES WILL ONLY BE NEEDED WHEN THE AMOUNT OF HORSES ATTENDING A SHOW OVERWHELMS THE ABILITY TO GET HORSES PREPARED VERSUS STALL CHORES AND MAINTENANCE DUTIES.

## SHOWING FEES

\$\$\$ THERE IS NO FEE FOR SHOWING HORSES IN TRAINING AS LONG AS THE OWNER IS PRESENT TO PROVIDE GROOMING AND HAVE THE ANIMAL READY FOR US TO SHOW.

\$15.00 PER DAY WILL BE CHARGED IN ADDITION TO THE STANDARD DAY FEE WHEN THE OWNER IS NOT PRESENT OR IS NOT INVOLVED IN PREPARATION

FUTURITY CLASSES, CONGRESS SWEEPSTAKES AND THE OPEN WORLD SHOW ARE EXCLUDED FROM THIS CHARGE

FEES FOR THESE EVENTS WILL BE PRIVATE TREATY

## SHOWING FEES NON TRAINING HORSES (SUBJECT TO AVAILABILITY)

ALL NON-TRAINING CUSTOMERS ARE SUBJECT TO A \$30.00 FLAT RATE CHARGE PER DAY. THESE CHARGES ARE TO BE CHARGED TO MAKE PRICING FAIR TO FULL TIME TRAINING CUSTOMERS.

ALL OTHER FEES WILL BE CHARGED AS THE INDIVIDUAL WAS AN "IN-TRAINING" EXHIBITOR. INCLUDING REGULAR DAY FEES, THE SPLIT OF TACK STALL, AND TRAINER'S HOTEL CHARGES, AND MEAL STIPENDS.

## AWARDS AND MONIES EARNED:

ALL MONIES EARNED, INCLUDING CASH AWARDS WHERE ANY OF THE MIL-MAX TRAINERS ARE THE EXHIBITOR, MONIES WILL BE DIVIDED 50/50. AWARDS, WHERE FOR EXAMPLE, MULTIPLE AWARDS ARE WON. THE CUSTOMER SHOULD FEEL OBLIGATED TO PROVIDE AN AWARD FOR THE EXHIBITOR/TRAINER AS WELL. THIS INCLUDES CONGRESS AND WORLD SHOW JACKETS. IF A JACKET IS AWARDED TO A HORSE SHOWN BY THE TRAINER, THE OWNER IS TO PROVIDE THAT TRAINER WITH ONE AS WELL.

## SHOW FEES CONCERNING RESPONSIBLE CHILDREN:

FROM TIME TO TIME IT IS NECESSARY TO TAKE MINOR CHILDREN WITH US TO A SHOW OR SIMILAR EVENT. IN THESE CASES WE WILL REQUIRE A COPY OF THE CHILD'S INSURANCE CARD AND A RELEASE FORM TO

ALLOW US TO ACT AS CARETAKER IF AN ACCIDENT SHOULD OCCUR. THERE WILL ALSO BE A DAY FEE OF \$50/DAY IN ADDITION TO BEING CHARGED A PERCENTAGE OF THE ACCOMMODATIONS IF NO OTHER IS PROVIDED.

## EXPENSES

EXPENSES ARE ANY AND ALL OUT OF POCKET EXPENSES INCURRED BY THE MIL-MAX STAFF WHILE INVOLVED IN SHOW LOCATION, THE PREPARATION OF STAGING AREAS OR THE TRANSPORTATION OF ANIMALS, VEHICLES, OR EQUIPMENT.

*EXPENSES ARE TO BE DIVIDED EVENLY BETWEEN ALL CUSTOMERS ATTENDING THAT EVENT REGARDLESS OF HOW MANY DAYS IN ATTENDANCE.*

## OFFICE CHARGES

A COVER CHECK IS REQUIRED TO ACCOMPANY YOUR HORSE TO THE SHOW WHEN IT TRAVELS TO A SHOW WITHOUT HAVING YOURSELF IN ATTENDANCE AND HAVING US ACT AS AGENT ON YOUR BEHALF. THIS ALSO APPLIES TO SHAVINGS THAT ARE CHARGED SEPARATE FROM THE SHOW TAB.

IF ANY OR ALL EXPENSES ARE COVERED BY MIL-MAX TRAINING CENTER AN OFFICE FEE OF \$25.00 WILL BE APPLIED, IN ADDITION TO THE AMOUNT INCURRED.

## CANCELLED STALLS

ALL STALLS THAT ARE CANCELLED WHERE THE SHOW HAS A NO REFUND POLICY WILL BE THE RESPONSIBILITY OF THE OWNER.

## STALL RESERVATIONS

PLEASE TRY AND BE COURTEOUS WHEN REQUESTING STALLS FOR AN UPCOMING SHOW. SHOWS ANYMORE HAVE LIMITED STALLS IN THE BETTER LOCATIONS, SO IT IS IMPERATIVE THAT YOU MAKE YOUR DECISIONS AS EARLY AS POSSIBLE SO WE CAN MAKE THOSE RESERVATIONS. AT THE "BIGGER" SHOWS AND CIRCUITS, GOOD STALLS ARE DIFFICULT TO SOMETIMES GET. IT IS OUR REPUTATION THAT ENSURES THOSE STALLS ARE OURS TO GET. IT IS OUR REPUTATION ON THE LINE IF WE INCONVENIENCE MANAGEMENT BY ADDING OR SUBTRACTING STALLS AT THE LAST MINUTE. WE TRY TO PUT OUT A LIST OF POSSIBLE SHOWS AS EARLY AS POSSIBLE, SO PLEASE TRY TO LET US KNOW YOUR PLANS. A TENTATIVE SHOW SCHEDULE WILL BE PROVIDED TO ENSURE YOU CAN MAKE DECISIONS EARLIER AND MORE CONVENIENT.

## ENTRIES:

### CONGRESS/WORLD SHOW ENTRIES:

ENTRIES FOR THESE SHOWS ARE DIFFICULT TO NAVIGATE. THERE IS A KNOWLEDGE OF EACH OF THESE SHOWS THAT REQUIRES A LITTLE NAVIGATION TO COMPLETELY ORGANIZE WHERE AN AGENT IS INVOLVED WITH MULTIPLE CLIENTS AND TENURE IN STALLING LOCATIONS. IT IS FOR THIS REASON WE REQUIRE ALL ENTRIES FOR THESE SHOWS TO BE HANDLED BY MIL-MAX TRAINING CENTER.

A \$15.00 OFFICE CHARGE PER HORSE WILL BE INCURRED TO COVER EXTRA TIME TO ORGANIZE VETERINARY HEALTH PAPERS, COGGINS, COPIES OF PAPERS, COPIES OF MEMBERSHIP CARDS, ENTRIES AND STALL RESERVATIONS.

## VETERINARY CHARGES

ALL VETERINARY SERVICES WILL BE BILLED DIRECTLY TO YOU.

PLEASE BE CONSIDERATE AND TAKE RESPONSIBILITY FOR YOUR VETERINARY ACCOUNTS. UNDERSTAND HOW YOUR RELATIONSHIP WITH A VETERINARIAN THAT WE WORK WITH CONSISTENTLY, ALSO IS A DIRECT REFLECTION ON US. PLEASE KEEP IN MIND WE TRY PRIMARILY TO WORK WITH WOODLAND RUN IN GROVE CITY. THEY REQUIRE ALL SERVICES TO BE PAID FOR UP FRONT. THEREFORE, YOU WILL BE REQUIRED TO PROVIDE A CHECK OR CREDIT CARD TO COVER THE COST.

WE KEEP MANY MEDICATIONS ON HAND TO ENSURE THE SAFETY, HEALTH, AND COMFORT OF ALL OF THE ANIMALS IN OUR CARE SHORT TERM OR EMERGENCY PURPOSES. WE PROVIDE THIS PARTICULAR SERVICE FREE OF CHARGE.

LONG TERM MEDICATIONS, INCLUDING BUTE, TO BE DISPENSED DURING SHOW, REGUMATE, AND OTHER SIMILAR SUBSTANCES ARE THE FINANCIAL RESPONSIBILITY OF THE CLIENT.

IN INSTANCES WHERE AN ANIMAL HAS TO BE HAULED TO A VETERINARIAN, STANDARD MILEAGE AND EXPENSE CHARGES WILL APPLY, IN ADDITION TO A \$ 50.00 FEE.

FARRIER: THE FARM WILL DESIGNATE A PROFFERED BLACKSMITH THAT WE FEEL CAN ASSIST US IN PROVIDING THE PROPER SHOEING ACCORDING TO OUR SPECIFICATIONS. ALL CHARGES FOR THIS SERVICE WILL BE INVOICED TO EACH HORSE SEPARATELY. THE FARM WILL NOT BE RESPONSIBLE FOR ANY PART OF FARRIER SERVICES. IT IS EXPECTED FOR THESE CHARGES TO BE PAID IN FULL AND UP TO DATE AT THE TIME OF SERVICE. INVOICES FOR SHOEING WILL BE BILLED DIRECTLY FROM THE BLACKSMITH.

### HAULING

HAULING- \$.65 PER MILE ( \$25.00 MINIMUM )

### TO BE ENFORCED IN 2019:

IN ORDER TO COMPENSATE THOSE INSTANCES WHERE THE CUSTOMER CANNOT ACCOMPANY A DRIVER TO A DESTINATION. WHERE THE CUSTOMER'S VEHICLE, TRAILER, OR ENTIRE RIG IS USED FOR TRANSPORTATION, PICKUP, OR DROP OFF, WE BELIEVE IT IS NECESSARY TO CHARGE A MILEAGE DRIVING CHARGE FOR THE TIME ON THE ROAD, SIMPLY AS A COURTESY.

MIL-MAX STAFF DRIVING YOUR RIG, MOTORHOME, VEHICLE OR ACCOMPANYING YOU TO A SHOW OR VET IN A VEHICLE OF OUR OWN – \$.45 PER MILE ( \$25.00 MINIMUM )

BRAIDING: \$50.00

BANDING: \$30.00

BODY CLIPPING: \$150.00

## EQUIPMENT CHARGES:

WE DO NOT CHARGE FOR THE USE OF EQUIPMENT. DURING THE PERIOD OF TRAINING, THERE MAY BE THE NEED TO EXPERIMENT WITH SEVERAL DIFFERENT PIECES OF EQUIPMENT. WE IN NO WAY EXPECT OUR CLIENTS TO PURCHASE ALL OF THE EQUIPMENT WE MAY UTILIZE DURING THAT TIME. HOWEVER, WE DO EXPECT YOU AS CLIENTS TO RESPECT OUR PROPERTY AND RETURN IT TO ITS APPROPRIATE PLACE. WHETHER IT BE IN OUR TRAILER OR ON A WORK HEADSTALL, WE WOULD APPRECIATE YOUR ATTENTION.

IF AN EQUIPMENT ITEM IS EITHER DAMAGED, LOST OR BROKEN WHILE IN A CUSTOMER'S CARE, OR DESTROYED BY AN ANIMAL, IT WILL BE REPLACED AT THE EXPENSE OF THE CUSTOMER . THIS INCLUDES BUT IS NOT LIMITED TO:

TRAILER

STALLS

TACK

FEEDERS/BUCKETS

BLANKETS/COOLERS

HATS/ CLOTHING

MISC. EQUIPMENT

## PERSONAL EQUIPMENT:

MIL-MAX TRAINING CENTER WILL NOT BE RESPONSIBLE FOR SUPPLIES OR EQUIPMENT. ALL CLIENTS WILL PROVIDE PROVIDING THEIR OWN GROOMING SUPPLIES, TACK, SHOW CLOTHING, BLANKETS, SHEETS, WRAPS, COOLERS, ETC. WE DO PROVIDE STORAGE, HAULING, AND SET UP OF ALL TACK AND SHOW RELATED EQUIPMENT AT NO EXTRA COST. ALL SADDLE RACKS, HOOKS, AND HANGERS WILL BE PROVIDED BY MIL-MAX TRAINING CENTER. PLEASE BE COURTEOUS AND HAVE YOUR EQUIPMENT COLLECTED AND READY TO LOAD WHEN IT IS TIME TO PACK THINGS UP. WE ENCOURAGE YOU TO TAKE CARE OF YOUR CLOTHING, CHAPS, HATS, ETC. WE WOULD CHOOSE NOT TO BE HELD

PERSONALLY RESPONSIBLE FOR THE SAFETY AND CARE OF SHOW CLOTHING.

### WORLD SHOW/NOVICE WORLD/CONGRESS RATES:

TRAINING HORSES- (MUST BE IN TRAINING 60 DAYS PRIOR TO SHOW)

\$400.00 FLAT RATE ( PAID IN ADVANCE PRIOR TO SHOW)

INCLUSIONS OF THE FLAT RATE:

THE FLAT RATE FOR THE WORLD SHOW AND THE CONGRESS IS AN ALL INCLUSIVE CHARGE FOR ALL OF THE HIDDEN CHARGES THAT GO UNNOTICED BY MOST CUSTOMERS THAT HAVE NOT PREVIOUSLY STALLED WITH A TRAINER. EXPENSES THAT ARE NOT INCLUDED IN YOUR BASE MONTHLY TRAINING CHARGES THAT FALL UNDER FLAT RATE CHARGES ARE AS FOLLOWS.

SET UP CHARGES:

SET UP INCLUDES SEVERAL FACTORS. IT CAN RANGE FROM RAW MATERIALS USED TO BUILD A SETUP, SUCH AS PLASTIC SHEETING, LUMBER, MULCH, PLANTS, AND ANYTHING THAT COULD PERTAIN TO THE PRESENTATION OF STALL FRONTS OR THE SURROUNDING DISPLAY AREA.

FURNITURE AND APPLIANCES:

FLAT RATE ALSO COVERS APPLIANCES AND ANY FURNITURE BROUGHT INTO THE SETUP, THIS HOWEVER DOES NOT INCLUDE ANY RENTED ITEMS. THOSE CHARGES WILL BE DIVIDED.

TRANSPORT/FUEL:

IT IS BY FAR THE MOST OVERLOOKED EXPENSE. THE AMOUNT OF ADDITIONAL FUEL SPENT IN EXTRA TRAVEL TIME WHICH CAN BE ANYWHERE FROM AN EXCESS OF 5-10+ TIMES THE AVERAGE ON A WEEKEND. RENTAL OF EXTRA TRAILERS AND VEHICLES REQUIRE US TO PAY FOR EXTRA FUEL AND MULTIPLE TRIPS.

ADDITIONAL HELP:

SOME BUILDS ARE LARGE AND REQUIRE US TO HAVE EXTRA ASSISTANCE TO PUT TOGETHER. THESE PEOPLE ARE GENEROUS AND

DON'T ASK TO BE PAID, BUT THEY STILL NEED TO BE FED, WHICH IS AN ADDITIONAL COST OUT OF OUR POCKET. ADDITIONAL HIRED LABOR, HIRED TO CLEAN STALLS AND LUNGE HORSES WHEN NUMBERS ARE LARGE MAY SEEM TO BE NOT NEEDED TO A CUSTOMER, BUT IS IN FACT A NECESSITY TO PROPERLY PREPARE YOUR HORSE FOR A LARGE EVENT. IF OUR TIME IS SPENT CLEANING STALLS AND STANDING IN LINE TO LUNGE, THE LESS TIME YOUR HORSE IS ACTUALLY BEING SCHOOLED. THE CHARGE OF WAGES AND HOUSING OF THE EXTRA HELP WILL BE DIVIDED. SEPARATE ARRANGEMENTS WILL BE MADE FOR MEALS.

#### MEALS:

A STANDARD DAY FEE IS DESIGNED TO BE A PORTION OF OUR MEALS. SO IN THIS SCENARIO, A PORTION OF THE FLAT RATE COVERS MEALS WHILE WORKING ON THE BUILD OR IN TRANSPORT.

#### OVERTIME:

A TYPICAL DAILY ROUTINE FOR US AT THE FARM IS FROM 9-10 HOURS. DURING SOME OF THE SET UPS, THE HOURS CAN REACH INTO THE 12-15 HOURS. A PORTION OF THE FLAT RATE COMPENSATES US FOR THE ADDITIONAL HOURS WORKED TO PROVIDE AN ATTRACTIVE AND FUNCTIONAL DISPLAY.

#### ADDITIONAL OVERTIME:

THE LARGEST PORTION OF THE FLAT RATE IS APPROPRIATED TO OVERTIME IN TRAINING AND LESSONS. THE AVERAGE DAILY TRAINING TIME PER HORSE ON A NORMAL TRAINING DAY IS 1- 1.5 HOURS DAILY. EACH MONTH OF TRAINING INCLUDES 4 LESSONS. THE AVERAGE TIME INCLUDED ON A TYPICAL DAY FEE CHARGE IS 1 PRACTICE THE DAY PRIOR TO SHOWING. IN THE CASE OF THESE LARGE SHOWS, THERE ARE MULTIPLE PRACTICES, ADDITIONAL RIDE TIMES, LATE NIGHT HOURS, AND EXTRAS ABOVE AND BEYOND. IF WE CHARGED THE CUSTOMARY HOURLY LESSON CHARGE TO THESE CIRCUMSTANCES, THE ACTUAL COST TO THE CUSTOMER WOULD BE ASTRONOMICAL.

ADDED TOGETHER, THE FLAT RATE DOESN'T BEGIN TO COVER WHAT EXPENDITURES ARE SUSTAINED ON OUR PART, WE DO OUR BEST TO KEEP THINGS AFFORDABLE FOR OUR CUSTOMERS. WE WANT YOU TO

BE INFORMED ON WHAT CHARGES YOU ARE BEING INVOICED FOR. WE JUST ASK SINCERELY THAT YOU TAKE INTO CONSIDERATION THAT WE CANNOT AFFORD TO JUST "BREAK EVEN". THIS IS OUR BUSINESS AND OUR LIVELIHOOD, WE DO STILL HAVE TO PAY OUR OWN BILLS AS WELL.

PLEASE NOTE:

OCCASIONALLY, IT WILL BE NECESSARY TO PRE-BILL HOTEL ROOMS DEPENDING ON THE AVAILABILITY AND LENGTH OF THE STAY. MILEAGE ONE-WAY MAY ALSO BE NEEDED TO BE PRE-BILLED DEPENDING ON OUR CAPABILITY TO FRONT THE CHARGES AT THE TIME OF DEPARTURE. WE APPRECIATE YOUR UNDERSTANDING IN THE OCCASION OF THESE CIRCUMSTANCES.

### **SALES:**

**WE PROVIDE THE SERVICE OF SALES AND ASSISTANCE IN PURCHASING HORSES. GIVEN THE TIME AND ORGANIZATION OF TIME, COMMUNICATION, VIEWING AND MAKING VIDEO ETC. WE RESERVE THE RIGHT TO CHARGE A 10% FEE FOR BEING INVOLVED IN EITHER THE PURCHASE OR SALE OF A HORSE. THIS CHARGE WILL ALSO INCURRED IF THE HORSE IS SOLD OR PURCHASED WHILE BEING IN OUR CARE, EVEN IF WE ARE NOT PERSONALLY INVOLVED.**
