## Statewide Updates: Turkey Season

• Ohio hunters harvested 14,442 wild turkeys through Sunday, May 23, during the spring wild turkey hunting season. Spring wild turkey hunting concluded Sunday in Ohio's south zone, which includes 83 counties. Hunting in the northeast zone (Ashtabula, Cuyahoga, Geauga, Lake, and Trumbull counties) is open until Sunday, May 30.

## Statewide Updates: Event Funding

- Opportunities include deer, waterfowl, dove, and more.
   Locations range across the state.
- The application fee for each hunt is \$3. To apply, visit

   customer account and navigate to the controlled hunts
   using the tabs.
- Lotteries will be held the first week of August. You will receive an email with your results or can check the status of your application by visiting www.ohiogamecheck.com. Select "Manage your customer account," sign in, then select "View Your Lottery Applications and Results."

## **Statewide Updates: Reduced Perch Limit**

The daily yellow perch limit has been reduced to 10 per day in the Lake Erie Central Zone from May 1, 2021, to Feb. 28, 2022.

- Central Zone boundaries:
  - Western boundary: W 82° 30.000'
  - Eastern boundary: W 81° 20.000'
- This regulation has been put in place due to declining perch populations in the Central Zone.

## Statewide Updates: 17-Year Cicada

- After 17 years under ground, Brood X cicadas are emerging by the billions!
- They will live for about 4-6 weeks above ground, which means they will start dying off in late June and July. Before they die, they mate. The female will lay eggs in the ground which will emerge in 2038!
- Cicadas do not bite and are harmless to humans, other than their impressive noise. You can even fry some up for dinner!
- Cicadas are a feast for animals, including turkey poults. Historically, turkey seasons following a cicada emergence experience an uptick in harvest.





## Statewide Updates: Tracking Swans

- In 2019, the University of Minnesota equipped trumpeter swans in Minnesota, Michigan, Ohio, Iowa, Wisconsin, & Manitoba with GPS-GSM transmitters affixed to neck collars with 2-character alpha-numeric codes.
   Researchers are hoping to use this study to evaluate migration patterns, local movements, habitat use, genetics, & survival of trumpeter swans in the reestablished Interior Population.
- You can help by reporting marked swans throughout the breeding season! Marked swans have been seen at Magee Marsh, Killdeer, and Big Island wildlife areas.
   When observing swans, do not disturb them. To view the recent locations of the marked swans, click here.
- Researchers are interested in the following information:
  - Identifying information (collar code)
  - Date, time, & location of observation
  - Nesting status, behavior, & presence of other swans (mate, cygnets)

- Wildlife sighting reports are important in population monitoring and setting hunting regulations and bag limits.



## Statewide Updates: H2Ohio

- H2Ohio is expanding statewide! Currently, over \$50 million has been put into H2Ohio wetland projects.
- Current projects such as the St. Joseph River Sustainable Ag Project (Williams Co., \$1.5 million), North Ridge Hunt Club River Project (Ottawa Co., \$70,000), and Redhorse Bend Floodplain Project (Sandusky Co., \$976,000) are in the Lake Erie Watershed. Future projects will also occur in the Ohio River Watershed.
- 150 additional projects have been approved.
   133 will construct wetlands (2,422.5 acres) and
   17 will create riparian buffers (113.5 acres).

### **Statewide Updates: Landowner Opportunities**

#### **Environmental Quality Incentive Program (EQIP)**

- ✓ Administered by the Natural Resources Conservation Service in your county
- ✓ Pays for many different land management practices including wetland enhancements, tree planting, native grass and wildflower establishment, invasive species removal, timber stand improvement, etc.

A 2022 deadline has not yet been announced, but applications can be submitted at any time.

### Conservation Reserve Enhancement Program (CREP) & Conservation Reserve Program

(CRP)

- ✓ Administered by Farm Service Agency in your county
- ✓ Land must have cropping history (corn, soy, wheat, etc.)
- ✓ Yearly payments for life of the contract (10,15, or 30 years)
- ✓ Establishment costs and incentive payments at sign up for many practices
- ✓ Some practices can be signed up at anytime (riparian areas, filter strips, wetlands, etc.)

Sign up has not yet been announced. Contact your county office and they will call you when the application period has been announced.

#### **Water Quality Incentive Program**

- ✓ Another WQIP is in the discussion stage for this fall/winter. Details are still being worked out and the program has not yet been confirmed.
- ✓ Additional \$2,000/acre when partnered with a CREP contract and CP23/CP23A wetland practices and/or the CP22 Riparian Buffer.

## District 3 Updates: Habitat Work

October 2020 through March 2021, through cooperative timber agreements, D3 conducted timber harvests on four wildlife areas (Zepernick, Killbuck, Funk Bottoms, Mosquito Creek) totaling 154 acres. A total of 618,712 board foot of timber were harvested. Harvest types included thinning, edge feathering, and regeneration cuts.

The picture to the right is from the timber cut at Zepernick Wildlife Area. These are mostly poplar trees that are waiting to be loaded on the truck.



DOW are currently preparing for the next harvest season. Timber harvests are planned for Brush Creek, Mosquito Creek, and Spencer Lake Wildlife Areas. Consulting foresters are presently marking timber on these





Division of Forestry is conducting a timber cut on the section of Yellow Creek State Forest that is adjacent to Highlandtown. The purpose of this cut is to remove trees infected with oak wilt disease. An MOU is in the works to allow DOF to skid the logs and place the landing on Highlandtown Wildlife Area.

Invasive Species Control - DOW currently have 395 acres under contract to be chemically treated before the end of this FY. The major invasive species being treated consist of Glossy Buckthorn, Ailanthus, and Phragmites. This work will take place on 5 Wildlife Areas. Mosquito Creek – 220ac, Brush Creek – 46ac, West Branch – 8ac, Berlin – 90ac, Hambden Orchard – 31ac. The acres being treated on Brush Creek and Mosquito Creek are either follow-up treatments or are in preparation for future timber cuts per their 10year forest management plan.

To date, the NWTF Maple Country Chapter has purchased and planted over 1000 trees here as well as funded the original mulching project which started this planting effort. Thanks, NWTF!



The American Woodcock Society, Whitetails Unlimited, and the Ashland County Chapter of Pheasants Forever, have partnered with the Killbuck Marsh Wildlife Area to establish early stage of successional habitat. This ongoing project with provide critical habitat for numerous species of wildlife.


### **District 3 Updates: Walleye Egg Collection**







Fish tech Cameron McCune with double catch flathead catfish, a massive female walleye, and yellow perch and crappie duo!



Walleye eggs were collected on Mosquito Reservoir in March to produce walleye and saugeye, a female walleye/male sauger hybrid that does well in some of Ohio's lakes. Fish Management crews, with the help of Law Enforcement and Wildlife Management staff, wrapped up another excellent year of egg collection in late March. A total of 741 quarts of walleye eggs were collected for the hatchery this year. In one day alone (March 18) the crews collected a one-day record of 144 quarts for production. With 125,000 eggs per quart, this translates into 92,000,000 eggs collected! These fish will be grown in our hatcheries and stocked out this spring at a lake near you.

We were impressed with a 48" spawned-out muskie we netted on Leesville during muskie egg collection efforts. – submitted by biologist Chris Aman

resumed collecting muskie eggs on Leesville Reservoir in 2021. This year, due to the ongoing pandemic, Ohio was not going to receive its annual allotment of muskie eggs from out of state. But with excellent catches of muskies at Leesville, crews were able to secure the entire state's needs for raising this toothy critter. Close to 20 quarts of fertilized muskie eggs were provided to our hatcheries, who will grow these fish and stock them in the early fall. - submitted by biologist Matt Wolfe



### **District 3 Updates: Ohio River Catfish Survey**

District Three Fish Management personnel teamed up with staff from Districts 4 and 5 (bordering the Ohio River) and the Inland Fisheries Research Unit to conduct low-frequency electrofishing on the Ohio River to assess flathead and blue catfish populations. This work is being conducted to develop a standardized sampling approach to assess relative abundance, growth rates, and ages of trophy Ohio River catfish populations.
