

### Statewide Updates: New Website




Explore and get familiar with our new mobile-friendly website at <u>ohiodnr.gov</u>! Some tips for using the site:

### Statewide Updates: Deer Season

- 71,650 harvested during deer gun week (*Last 3-year average: 65,566*)
- 79,499 harvested by archery hunters
- 5,795 harvested during 2-day youth gun weekend
- Deer harvest total: 156,944

### Statewide Updates: Chronic Wasting Disease

The Ohio Department of Natural Resources (ODNR) Division of Wildlife has identified a positive test for Chronic Wasting Disease (CWD) in a wild Ohio white-tailed deer in Wyandot County. The Division of Wildlife is gathering additional details about the adult male deer taken by a hunter on private property. Tissue samples were submitted for testing by a taxidermist and the positive test was identified after results were obtained on Thursday, December 10, 2020.



### Statewide Updates: Lake Erie Walleye Boom


- The Lake Erie walleye boom continues.
   Sampling for young-of-year walleye in 2020 showed another above average year class. The graph to the right is a good indication of what will be the adult population in 2 years.
- The Ohio August west basin trawl survey index in 2020 was the 8th best in the 34-year sampling window. This is well above the that windows average. Add those fish to the big hatches in 2015, 2018 and 2019 and the future of walleye fishing in Lake Erie seems secure for a long time.

### **Statewide Updates: Hunter Education**



hunter-ed.com/ohio/

- Online Hunter Education is for Ohio residents 12 years of age or older (those under 12 can purchase and use the apprentice license until in-person courses are available again).
- This version of hunter education allows students to complete the entire course online. This online course will take approximately eight hours to complete, but you may stop and pick up where you left off in the course as you please. There are quizzes at the end of each unit. You must pass the unit quiz to proceed to the next unit. Students must pass a final exam to receive certification. There is a fee paid to the online vendor at the time of registration prior to starting the course.



# Statewide Updates: Landowner Opportunities

#### **Environmental Quality Incentive Program (EQIP)**

- ✓ Administered by the Natural Resources Conservation Service in your county
- ✓ Pays for many different land management practices including wetland enhancements, tree planting, native grass and wildflower establishment, invasive species removal, timber stand improvement, etc.

Application Deadline: January 15, 2021

#### Conservation Reserve Enhancement Program (CREP) & Conservation Reserve Program (CRP)

- ✓ Administered by Farm Service Agency in your county
- ✓ Land must have cropping history (corn, soy, wheat, etc.)
- ✓ Yearly payments for life of the contract (10,15, or 30 years)
- ✓ Establishment costs and incentive payments at sign up for many practices
- ✓ Some practices can be signed up at anytime (riparian areas, filter strips, wetlands, etc.)

Sign up has not yet been announced. Contact your county office and they will call you when the application period has been announced.

#### **Wetland Quality Incentive Program**

- ✓ Only available in the Western Lake Erie Basin
- ✓ Land must be eligible for CREP
- ✓ One-time incentive payment of \$2,000 per acre for wetland practices (CP23A and CP23) and riparian buffers (CP22) only

### District Three Updates: Bluebird Nest Boxes

In an effort to keep plans from months ago moving forward but in a different capacity, a
partnership between DOW and Summit Metro Parks will lead to 50 families picking up, taking
home, and constructing bluebird nest boxes. The Highlandtown Wildlife Area crew, Jeff and
Vern, made the kits and Communication Specialist Jamey Emmert helped distribute them. A
YouTube video, produced by Summit Metro Parks, will feature instructions on proper
construction of the box, location selection, and maintenance tips.





## District Three Updates:120th Christmas Bird Count



A virtual birding academy for staff kicked off last spring, encouraging DOW employees to consider birding
as another opportunity to get outdoors and enjoy additional wildlife-related recreational opportunities.
Presentation topics so far include basics of bird watching, basic bird identification, the history of bird
populations in Ohio, current population trends, and most recently, participating in the international
Audubon Christmas Bird Count population census. This event involves thousands of volunteers across
the western hemisphere and is the longest-running citizen science project in the world. Are you

## District Three Updates: Taxidermy Donations

### District Three Updates: Grand River WA Access


Access was improved in November on Grand River Wildlife Area by the acquisition of a 5-acre inholding on the northwest portion of the area. Parking access has always been limited on this portion of the area due to roadside ditches/wet ground along Brigden Road and this 5-acre property has enough dry ground with an existing gas well entrance to develop a parking lot for

hunters.





### **District Three Updates: Timber Harvest**



Timber harvests are necessary to diversify habitats and benefit wildlife species. Funk Bottoms, Killbuck Marsh, Mosquito Creek, and Zepernick Lake wildlife areas are all having timber harvests this fall/winter that total approximately 153 acres. Ohio's forests are maturing and are lacking the young forest, early successional, high stem density habitat component many wildlife species depend upon. The results of these timber harvests will help create a mosaic of habitat types across the landscape that will benefit both wildlife and hunters.

# District Three Updates: Chronic Wasting Disease

Chronic Wasting Disease (CWD) sampling priorities and goals were recently updated statewide that resulted with many northeast Ohio counties getting relatively high quotas compared to the rest of the state.

County quotas are based on a variety of risk factors that are weighted within each county of the state including: deer and hunter density, deer habitat (forest, grassland, etc.), average distance hunters travel from home to the place most frequently hunted, number of taxidermists/processors, number of captive cervid facilities, number of hunters in each county that hunt out of state, presence of wildlife rehabilitators, and distance to known CWD positives in the wild deer herd.

Staff sampling road-killed deer and working with taxidermist/processors are the primary means for CWD sample collection.

In the fall of 2020 (as of mid-December), we have sampled 1,276 deer in northeast Ohio. Additionally, 181 deer were recently sampled during the week of deer gun season for the existing Disease Surveillance Area in Holmes/Tuscarawas Counties.

### District Three Updates: Surveys

Fish Management staff worked within developed protocols and were able to conduct our routine fish assessment work this fall evaluating regional fish population abundances, fish sizes, growth rates, stocking success, and regulation effectiveness. Surveys conducted were as follows:

Hybrid striped bass stocking evaluation: Dale Walborn reservoir

Walleye stocking evaluation: Pymatuning lake, Berlin lake

Crappie population assessment: LaDue reservoir, Berlin lake, Pymatuning lake

Walleye population assessment: Berlin lake, Lake Milton, West Branch reservoir

Hybrid striped bass population assessment: Guilford lake

Ohio River walleye and sauger population assessment: New Cumberland Dam tailwater (Pike Island Pool)



# District Three Updates: Stockings

Waters through northeast Ohio were stocked with channel catfish during October. State Fish Hatchery staff use their large trucks to stock large lakes and reservoirs and Fish Management District Three personnel use our hauling equipment for stocking of smaller lakes and regional fishing ponds.
