The Seller guarantees that the above-described animal is a purebred dog and is registerable with the American Kennel Club.

The Buyer shall keep the dog as a household pet.

The Buyer shall provide the dog with an adequate food, fresh water, shelter, affection, and medical care upon sickness, disease, or injury. Maintenance should include an annual health exam and routine vaccinations as recommended by a board-certified veterinarian. Humane care and maintenance in accordance with all current and future state, county, and municipal laws and ordinances where the Buyer resides. A fully fenced yard or other humane means of exercise. The dog shall not be kept chained or constantly outdoors. A collar and identification tag and/or microchip. Never permit the dog to roam unattended.

TERMS AND CONDITIONS OF SALE

_____ (Buyer's Initial) The dog shall reside with the buyer.

_____ (Buyer's Initial) The Buyer agrees that the dog appears to be sound and in good health at the time of purchase.

_____ (Buyer's Initial) **The Seller is not responsible for injury or exposure to communicable diseases sustained to the dog due to the negligence of the Buyer after delivery.**

_____ The Buyer is given 3 business days from delivery to have the animal checked by a Veterinarian for soundness. If for any genetic reason the dog fails the vet check, a replacement dog of equal value will be provided upon availability and upon the Seller receiving written notice of the veterinarian's report and the return of the dog.

_____ (Buyer's Initial) The Buyer shall notify the Breeder immediately if the dog cannot be kept by the Buyer. The Buyer and Breeder agree to keep each other informed of their current addresses.

_____ (Buyer's Initial) **If Buyer wishes to give or sell the subject dog to another party, the Seller is to be given written notice of such action. Seller must be provided with the name, address, and phone number of the person to whom the Buyer wishes to transfer the dog and the Seller will give written approval for the transfer.** The dog shall not be sold, transferred, or given to any individual or to any retail or wholesale establishment for the purpose of sale or resale to the public or to any research institution where medical experimentation or other practices take place.

_____ (Buyer's Initial) **The Buyer is prohibited by this contract from disposing of this animal at any time to a Shelter, Pet Shop, Animal Broker or Rescue Group without written approval from the Seller. If Buyer disposes of the above named dog at a Shelter, Pet Shop, Animal Broker, or Rescue Group, without the written approval from the Seller, the Seller retains the right to take the Buyer to Civil Court for an amount up to five times the purchase price of the dog. Any legal actions will be done in the Sonoma County California.**

_____ (Buyer's Initial) **In the event the Buyer is unable to keep the dog and, if the the buyer would like to return the dog, the dog must be returned to the seller at any time of the life of the dog.**

_____ (Buyer's Initial) **the buyer agrees to sign the necessary papers to return the dog to the breeder as sole owner of the dog.**

_____ (Buyer's Initial) **This animal is sold as a companion/pet with Limited AKC Registration unless otherwise noted in the Additional Terms and Conditions portion of this contract.**

_____ (Buyer's Initial) **The dog will be spayed or neutered at the appropriate time usually after 1 year. The buyer agrees to not attend dog parks. Dog parks are not safe especially for puppies 6-12 mo of age. The goal of socializing young puppies is to positive experiences and to avoid overwhelming or frightening experiences. Instead of taking dogs to dog parks, attend puppy classes to meet age appropriate playmates.**

TERMS AND CONDITIONS OF SALE

AKC Limited Registration restricts this animal from being shown in Conformation Events and restricts the dog from breeding. The Seller is the only agent allowed to remove the Limited Registration Status and is willing to discuss removal based not only on the merits of the dog, but with consideration and compensation to the Breeder for such removal of Limited Registration.
