

# McNASTY CUSTOMZ

Thank you for your recent purchase of the McNasty Customz HONDA TALON Tailgate. When Purchased with Powder Coating please keep in mind that it is just that a coating. Powder Coat is **not** indestructible and **can** scratch and chip although it is highly resistant to both. When installing the Doors there are some factors that need to be considered for a proper fit.

- Has the Buggy ever been into an accident?
- Any Aftermarket parts?
- Prior Modifications

Although we have designed them to work with most Aftermarket Accessories, we cannot guarantee proper fitment with all of them and is the buyer's responsibility to check compatibility as some modifications may be required.

1. **You will need A Drill with a ¼ Drill Bit, and a 10mm wrench**
2. Remove the 2 factory bolts from lower roll cage bung.
3. Position gate on rear deck.
4. Loosely attach the inner straps to roll cage with supplied hardware do not tighten yet..  
please note there are different angles of the straps make sure they are on appropriate side.
5. With supplied hardware insert 6mm bolt through gate into strap on each side with wash and nut. DO NOT Tighten yet.
6. Adjust the gate to your liking.
7. On the bottom panel of the gate where it meets the rear deck you will see 3 holes once you are satisfied with position of gate you may now drill one hole at a time placing the longer 40mm m6 bolt through the hole and fastening with supplied washer and nut. Drill all 3 holes and install hardware.
8. Tighten remainder of the bolts
