Safeguarding at Kaleidoscope School

This leaflet provides important information about safeguarding at Kaleidoscope.

The Safety and wellbeing of our children is paramount, and we will do all that we can to ensure that their time at Kaleidoscope School is as safe, happy, and healthy as possible.

Kaleidoscope aims to create and maintain a safe learning environment where all children and adults feel safe, secure, and valued and know that they will be listened to and taken seriously. Our school is committed to the principles outlined in 'working together to safeguard children'. In the department for Educations latest guidance and 'keeping children safe in education we review these updates annually.' and this implements policies, practices and procedures which promote safeguarding and the emotional and physical wellbeing of children, young people and staff.

Our Children have access to a bespoke curriculum and further learning opportunities, including emotional health and wellbeing, to support the development of the skills needed to help them stay safe, healthy and develop their self-esteem and understanding the responsibilities of being independent.

The school works closely with local Safeguarding Children Board, Children's services, and other outside agencies to ensure that we provide our children and families with the appropriate support that they require to live safe and healthy lives.

Who do I talk to?

All schools have a policy which tells people what to do if they think a child may be suffering abuse or neglect.

The staff at Kaleidoscope are all trained in Safeguarding and learn the signs of abuse/neglect. Also, the School has a Designated Safeguarding Lead [DSL] as well as a Deputy Designated Safeguarding Lead [DDSL]

Concerns

If you are concerned about the welfare of a child who attends Kaleidoscope School, you have a duty to report those concerns and safeguard the child.

You can either talk to a member of staff at school or contact your local authority Children's Services directly.

You are not expected to make any judgements on whether it Is abuse or not. It is the role of the DSL to decide if child abuse is a consideration or if the information received can be held on file.

Why do you keep concerns on file?

The DSL at school and the Deputy DSL's are trained under national guidelines to make judgements using a strict threshold criteria and if the concerns do not meet the threshold this could be the reason for keeping the concern on file.

Concerns can often be something small and not warrant intervention from Children's Services. However, over a period of time, a collection of small concerns can build a worrying picture. It is when we receive a number of 'small concerns' that we may contact Children's services to look at the picture it builds and make a judgement on intervention based on them.

Therefore, even the smallest concern, if filed, can help the DSL to gain the information to build a picture to ensure support is available.

Earliest Help

We will aim to provide support to all of our children and families at the earliest opportunity, therefore please contact our Family support Officer or DSL if you would benefit from this support.

If we believe that the concerns place a child at risk of immediate harm, then a referral will be made to Children's Services.

What if I still have a concern about a child?

- Speak to the DSL/DDSL about the continued concern
- Ask the headteacher to look into the concern.
- Follow the School Child Protection and Safeguarding Policy
- Contact your local authority social care team to report the concern directly.
