1. HPFC will in every way possible act in a professional and ethical manner. Personal issues of the players will be kept confidential, unless if we believe that the health/safety of the player is threatened by keeping quiet.
2. HPFC may not use any of the player's/parent's personal information anywhere else except for the club's use without their consent.
3. Each player will be attended to according to their own needs.
4. No form of bullying will be tolerated in the club.
5. HPFC commits to be always on time, if not, (due to any unforeseen circumstances) the parent/ guardian of the player will be informed, and the player will still be trained for the duration of their initial hours. We expect the same efforts from the player, regarding time management.
6. Once a player is signed up with HPFC, choosing comfort and looking for the easy way-out during training is not an option.
7. Parents are also encouraged to give the players full support for them to push themselves.
8. Parents are not allowed to coach the players during a training session/ match. A parent can ask the coach questions after the training session/ match.
9. Coaches may not take /post any photographs of the players unless the parent has given permission.

10. All payments should be made before the 3rd of each month. Players will not be allowed to participate until payment has been made. A proof of payment should be sent via WhatsApp to Sindile (066 220 4482).
11. There will be no refunds for any session missed. All cancellations must be done 30 days (1 month) in advance, failure to do so, the parent will have to pay for the upcoming month. The club will provide players with clearance letters if needed.
12. Players are expected to wear the correct type of shoes (soccer boots) to training and matches. A player will not be allowed to enter the field without soccer boots. Each player must have their own sheen guards on match days.
13. Each player MUST have their own playing kit; this is available from coach Enock. A full set of playing kit cost R 400.
14. All training sessions will take place at Curro Serengeti, Serengeti golf and wild estate, Kempton Park, 1619. On Fridays (14:00 -15:00) and Saturdays (08:00 -09:00) if there are no matches.
