At a recent Diving Industry Committee meeting, the IMCA announced that they are changing the periods for inspection and testing of cylinders to the same as the other diving sectors, namely 2 % and 5 years. This means a change to their Code of Practice D018.

As a result, we will be amending the training content for the IMCA Technician Inspection course as soon as this is confirmed.
