# **ENDOWMENT FUND**

As covered in our last issue (Spring 2014) we are ready to embark on a mission to build an ongoing "Rhodes Scholarship Endowment Fund".

We hope you are passionate about the education you received in your "Old Brooklyn" neighborhood and James Ford Rhodes in particular. Providing the resources to assure that those who follow us receive the same opportunity as we did is a responsibility we must all share.

Whether you feel a desire to "give back" for the education you received at Rhodes; as an expression of a passion for a cause or to energize family and friends along with loved ones, we know you will feel you have made a good choice in helping others. In our next newsletter we will have a space for the scholarship Endowment Fund news and we hope you will avail yourself of this opportunity to help our fund.

We ask that you consider a donation honoring:

- Your best friend in high school
- A deceased classmate
- A class or activity for which you are passionate
- A favorite high school sports team or activity
- A favorite teacher, coach or administrator
- Your graduating class by leading a class donation program

Donations can be made now in the following ways:







- Checks—which are an income tax deduction and an immediate benefit to the Alumni Association.
- Long-term appreciated securities—which can be deducted at full value as a tax deduction.
- IRA funds
- Real or personal property—"often allows an individual to contribute more than thought possible", (i.e. car, coin collection, paid up insurance policies, etc.)
- Remembering James Ford Rhodes High School in your will or trust with the ability to designate how it is to be used.
- Pledges—Knowing that personal financial circumstances change as the years go by and donation funds that don't exist today may exist tomorrow. If you wish to support our scholarship endowment fund you might want to show your commitment through a yearly pledge of a smaller amount over a longer period of time.

#### Rhodes Alumni Association is a 501(c)(3) organization and ALL donations are TAX DEDUCTIBLE.

The Cleveland Foundation is one of the organizations being considered to handle our endowment fund. We would benefit from their investment expertise. They are the oldest (1914) community foundation with current assets of \$1.8 billion. They require an annual administration fee for handling the fund but it would allow us to save legal expenses, etc. to set up our own fund. The advantage of having the fund professionally handled with continuity is a valued consideration. You will be informed as we consult with fellow Alumni and Hall of Famers.

We set a goal of \$200,000 on which a 3% return would allow us to continue to pay for our current yearly scholarship help for Rhodes seniors. Officers and Trustees of the Rhodes Alumni Association along with close friends have thus far donated \$34,497.00 to start our way to the \$200,000 goal. We also have received a pledge of \$25,000.00 from a Trustee's estate trust. Our goal may seem like a lot but with your help we can do it.

He was also awarded the Purple Heart, Bronze Star Medal and the Combat Infantryman Badge in which he takes the most pride. Scuba graduated from Rhodes High School in 1940 and by the end of 1942



he was drafted into the military. Even at 91, Scuba remains involved in local veteran's organizations. Thank you for your service to our country and thank you for your continued support of your alma mater, Rhodes High School.
