All respondents will be notified in writing of the decision as to qualifications. The Heritage House Museum of Orange County requires that prospective bidders must submit a completed Qualifications Statement as set forth herein. Failure to complete the Qualifications Statement may result in disqualification.

All entries on the forms must be completely filled in. Complete Qualifications Statement Forms must be submitted in duplicate to: Charlotte Alford at 905 W Division St, Orange, TX 77630. The Heritage House Museum of Orange County Board will review the Qualifications Statement Forms according to the Evaluation Criteria set forth herein. General Contractors whose Qualification Statements are determined to be acceptable will be identified as Qualified Prospective Bidders. Each respondent will be notified in writing of the determination. Only bids received from previously Qualified Bidders will be opened. All successful Qualified Bidders will be required to submit with the bid to the Heritage House Museum of Orange County Board, for its review and approval, the qualifications of all subcontractors who will be used on the project.

Scope of Work for the HERITAGE HOUSE MUSEUM OF ORANGE COUNTY ADMINISTRATION Building

Administration Building

Work includes but is not limited to-

OUTSIDE: Pressure wash, chemical wash, tear out insulation, batt insulation 4", R&R central air condenser unit - 3 ton, dumpster load and haul debris, muck out and clean debris from crawlspace, clean floor joist system, apply antimicrobial agent to floor joist system.

OFFICE 1: structural drying, clean stud wall, apply antimicrobial agent to more than the floor perimeter.

FLOOR: R&R underlayment 3/4 "BC plywood, R7R carpet pad, remove carpet, carpet.

WALLS: R&R baseboard - 2 ¼", seal and paint baseboards with two coats, r&R corner trim, seal and paint corner trim with two coats, detach and reset crown molding - 2 ¼", seal and paint crown molding with two coats, R&R paneling - high grade.

DOORS AND WINDOWS: R&R exterior door - metal - insulated- flush or panel style, paint door slab only with two coats, paint door/ window trim and jamb with two coats per side, R&R casing - 2 1/4", paint casings with two coats, door lockset and deadbolt - exterior - detach and reset.

OFFICE 2: Structural drying, clean stud wall, apply antimicrobial agent to more than the floor perimeter.

FLOOR: R&R underlayment - 2/4" plywood, R&R carpet pad, remove carpet, carpet.

WALLS: R&R baseboard - 2 ¼", seal and paint baseboards - two coats, R&R corner trim, seal and paint corner trim with two coats, detach and reset crown molding - 2 ¼", seal and paint crown molding with two coats, R7R paneling - high grade.

DOORS AND WINDOWS: R&R casing - 2 1/4", paint casing with two coats.

OFFICE CLOSET: Structural drying, Clean stud wall, apply antimicrobial agent.

FLOORING: R&R underlayment ¾" BC plywood, R&R carpet pad, remove carpet, carpet.

WALLS: R&R baseboard - 2 1/4", seal and paint baseboards - two coats, R&R paneling, paint the walls with two coats, Shelving - detach and reset.

DOORS AND WINDOWS: R&R interior door - Colonist- Prehung unit, paint door slab only with two coats, paint door/ window trim and jamb - 2 coats per side, door knob - detach and reset.

HALLWAY :Structural drying, Clean stud wall, apply antimicrobial agent.

FLOORING: R&R underlayment ¾" BC plywood, R&R carpet pad, remove carpet, carpet.

WALLS: R&R baseboard - 2 1/4", seal and paint baseboards - two coats, R&R paneling, paint the walls with two coats, Shelving - detach and reset.

DOORS AND WINDOWS: R&R casing - 2 1/4", paint casing with two coats.

BATHROOM: Structural drying, Clean stud wall, apply antimicrobial agent.

FLOORING: R&R underlayment ¾" BC plywood, R&R carpet pad, remove carpet, carpet.

WALLS: R&R baseboard - 2 ¼", seal and paint baseboards - two coats, R&R corner trim, seal and paint corner trim with two coats, detach and reset crown molding - 2 ¼", seal and repaint crown molding with two coats, R&R paneling - high grade.

CABINETRY: R&R Vanity, detach and reset vanity top.

DOORS AND WINDOWS: R&R interior door - Colonist- Prehung unit, paint door slab only with two coats, paint door/ window trim and jamb - 2 coats per side, door knob - detach and reset.

PLUMBING: detach and reset toilet, clean toilet.

UTILITY ROOM 2: Structural drying, Clean stud wall, apply antimicrobial agent.

FLOORING: R&R underlayment ¾" BC plywood, R&R carpet pad, remove carpet, carpet.

WALLS: R&R baseboard - 2 ¼", seal and paint baseboards - two coats, R&R corner trim, seal and paint corner trim with two coats, detach and reset crown molding - 2 ¼", seal and repaint crown molding with two coats, R&R paneling - high grade.

DOORS AND WINDOWS: R&R casing 2 1/4", paint casing.

HVAC ROOM: Structural drying, Clean stud wall, apply antimicrobial agent.

FLOORING: R&R underlayment ¾" BC plywood, R&R carpet pad, remove carpet, carpet.

WALLS: R&R baseboard - 2 1/4", seal and paint baseboards - two coats, R&R paneling.

DOORS AND WINDOWS: R&R interior door - Colonist- Prehung unit, paint door slab only with two coats, paint door/ window trim and jamb - 2 coats per side, door knob - detach and reset.

FILING ROOM: Structural drying, Clean stud wall, apply antimicrobial agent

FLOORING: R&R underlayment ¾" BC plywood, R&R carpet pad, remove carpet, carpet.

WALLS: R&R baseboard - 2 ¼", seal and paint baseboards - two coats, R&R corner trim, seal and paint corner trim with two coats, detach and reset crown molding - 2 ¼", seal and paint crown molding with two coats, R&R paneling - high grade.

DOORS AND WINDOWS: R&R Exterior door - metal- insulated - flush or panel style, R&R interior door - colonist - prehung unit, paint door slab only with two coats, paint door/ window trim and jamb - 2 coats per side, door lockset and deadbolt - exterior- detach and reset, door knob - detach and reset.

KITCHEN: Structural drying, Clean stud wall, apply antimicrobial agent.

FLOORING: R&R underlayment ¾" BC plywood, R&R carpet pad, remove carpet, carpet.

WALLS: R&R baseboard - 2 ¼", seal and paint baseboards - two coats, R&R corner trim, seal and paint corner trim with two coats, detach and reset crown molding - 2 ¼", seal and paint crown molding with two coats, R&R paneling - high grade.

CABINETRY: countertop - flat laid plastic laminate- detach and reset, R&R custom cabinets - base units.

DOORS AND WINDOWS: R&R casing - 2 1/4", paint casing

APPLIANCES: Fridge - clean and service, Range - clean and service.
