1. Purpose

3. Deposit Terms

- The Buyer agrees to place a non-refundable deposit of \$300.00 to reserve a puppy from a current litter.
- The deposit will be applied toward the total purchase price of the puppy.
- Puppies are chosen in the order deposits are received (first come, first serve)
- Deposits may be transferred to a future litter at our discretion.

4. Refund Policy

- Deposits are non-refundable unless:
 - The Breeder is unable to provide a puppy from the agreed litter or timeline.
 - The Breeder cancels the reservation for any reason.
- If the Buyer chooses to cancel the reservation for any reason, the deposit is forfeited.

5. Selection Process

- The Buyer will be notified when puppies are born.
- Puppy selections typically occur at 3 days- to a week old, after temperament and structure evaluations.
- Final balance is due at or before pickup, which is usually at 8 weeks of age.

6. Puppy Pickup

- Puppies must be picked up or scheduled for delivery within 7 days of their go-home date unless otherwise agreed upon in writing.
- A boarding fee of \$ 35.00 per night may be apply for delays beyond this timeframe.

7. Legal Agreement

This Agreement shall be governed by the laws of the State of Missouri. Any disputes shall be resolved in Christian County, Missouri.
