The Hitchcock and Tutt Duel Stage # 1



At a few minutes before 6:00 p.m., Hickok was seen calmly approaching the square from the south with his Colt Navy. Tutt was alone in the northwestern corner of the square. At about 75 yards, Hickok stopped, facing Tutt, and called out, "Dave, here I am." Tutt did not reply but stood with his hand on his pistol. Both men faced each other sideways in the dueling position and hesitated briefly. Then Tutt reached for his pistol. Hickok drew his gun and steadied it on his opposite forearm. Tutt missed, but Hickok's bullet struck Tutt in the left side between the fifth and seventh ribs. Tutt called out, "Boys, I'm killed," and collapsed and died.


<u>Staging</u>: Two pistols loaded with 5 rounds each holstered.


Rifle loaded with 10 rounds on the table at position 1 Shotgun, open and empty on the table at position 2

Gun order: Pistol, Rifle, Pistol and Shot gun

Starting Position: Start standing at position 1 with pistol in hand. Shooter says **"Boys I am Killed".**

ATB: With 1st pistol shot shoot the clay target and then put 4 shots on the circle target. If clay breaks, it's a 5 second bonus. With rifle triple tap the round target than alternate between the rectangle targets for 4 rounds starting on either end then triple tap the circle. Bring your rifle to position 2. With your 2nd pistol triple tap the center target then put 1 shot on each rectangle target from either end. With shot gun knock down the 4 shot gun targets in any order.

Gunfight in Lampasas Texas Stage # 2



The **Horrell brothers**, sometimes referred to as the **lawless Horrell boys** On June 7, 1877, John Higgins, in-laws Bob Mitchell and (William) Frank Mitchell, Bill Wren, and another brother-in-law, Ben Terry, rode into Lampasas. The Horrell brothers and several friends were already in town that day, gathered at the square. Who fired first is unknown, but it is believed that someone within the Horrell faction opened fire on the Higgins faction. When it was over, Bill Wren had been wounded, Frank Mitchell had been killed, and Horrell faction members Buck Waltrip and Carson Graham were dead.

<u>Staging</u>: Two pistols loaded with 5 rounds each holstered.


Rifle loaded with 10 rounds on table at position 1

Shotgun, open and empty on the table at position 1 or 2

Gun order: Rifle, then Pistols or shotgun.

Starting Position: Start standing at the table position 1 with hands at Texas Surrender. Shooter Says, "2 Horrell Boys are Dead"

<u>ATB:</u> With rifle Double tap the center target then sweep the 3 targets from either end and repeat instructions. Make rifle safe. If you shoot the shotgun next and it is staged at position 1 shoot the 4 shotgun targets until down. They may be shot between position 1 and 2 in any order. If shotgun is from position 2 knock down shotgun targets in any order. At position 2 with pistols repeat rifle instructions.

Stage # 3 Shootout at the Long Branch Saloon



Richardson strolled into the Long Branch Saloon and settled into a game of poker. Loving entered the bar and took a seat a table. The two men could be heard talking low to one another, Suddenly, Richardson said loudly "You wouldn't fight anything, you damned son of a bitch," to which Loving said calmly, "Try me and see. Richardson stood and drew his gun, which prompted Loving to do the same. Both men fired their weapons repeatedly, with Richardson firing five rounds and Loving firing six. When the shooting stopped, Richardson had been shot in the chest, the side, and the arm. Loving was grazed on the hand by one bullet, but otherwise was uninjured. Town Marshal Charlie Bassett quickly responded, having heard the shots, but Deputy Marshal Duffey arrived first, and took hold of Richardson as he crumpled to the floor. No one else in the saloon was injured. Loving was arrested as was standard procedure in such a case. On April 7, 1879, a coroners inquest ruled the shooting self defense, and Loving was released without charges.

Staging: Rifle loaded 10 rounds on the table at position 1


Pistols loaded 5 rounds each holstered.

Shotgun open and empty on the Table at position 2

Gun order: Rifle Pistols and Shot gun

Starting Position: Standing at the table holding hand cards in both hands Shooter Says: "**Try Me And See.**""

<u>ATB:</u>. With rifle at position 1 and pistols at position 2 put 2 shots on each square and 4 shots on the circle for 20 total round, **this is a round count**. Bring rifle to position 2 continue with your pistols. With shotgun knock down the 4 shot gun targets in any order.

Stage # 4 The Frisco Shootout



The shootout happened in Reserve New Mexico, and stemmed from the arrest of a cowboy, Charlie McCarty, who had been shooting into the air and into buildings at random while intoxicated. Shortly after the arrest was made, Sheriff Baca was confronted by a large number of the cowboy's friends. An intense shootout ensued, during which the cowboys increased in number to around eighty men. Legend has it that the cowboys fired more than 4,000 rounds into the house. Baca was not wounded by any of the rounds fired, but did return fire killing four of the cowboys, and wounding eight others. The standoff ended when the cowboys were unable to acquire more ammunition. With their ammunition supply depleted, they simply withdrew. The fight had lasted thirty-six hours.

Staging: Rifle loaded 10 rounds on the Table position 1.


Pistols loaded 5 rounds each holstered.

Shotgun open and empty on the table at position 1.

Gun order: Rifle, shot gun, pistols.

<u>Starting Position:</u> Standing at the table position 1 holding a box of ammo shooter says "We Need More Ammo"

<u>ATB:</u> Drop the box of ammo and with rifle do a "Z sweep from the top left or bottom right for 7 rounds then sweep the 3 middle horizontal targets from either direction. With shot gun from anywhere between the tables knockdown the 4 shot gun targets in any order. With pistols from position 2 repeat the rifle instructions.

Stage #5



Las Vegas Saloon Shootout Las Vegas New Mexico

Marshal Joe Carson and Mather entered Close and Patterson's Variety Hall after receiving complaints from citizens of rowdy customers inside. The "rowdy customers" were cowboys T.J. House, James West, John Dorsey, and William "Big" Randall, who had been going in and out of saloons and generally making trouble. At some point during the proceedings the cowboys were alleged to have thrown their glasses at a bartender and dared anyone present to stop them. Upon entering Marshal Carson demanded that the cowboys relinquish their weapons. They refused. A gunfight started; who drew and/or fired first is not known. Marshal Carson was killed almost immediately. Mather killed Randall, wounded West and put him out of the fight, and wounded Dorsey, who managed to escape with House. House and Dorsey were captured two weeks later, and an angry mob broke into the jail, pulled House, Dorsey and West from their cell, and lynched them.

Staging: Rifle loaded 10 rounds on the gun horse.


Pistols loaded 5 rounds and holstered.


Shotgun open and empty staged on the table.

Gun Order: Rifle first then pistols or shot gun

Starting Position: Standing at the gun horse with rifle in hand, shooter says, <u>"Lynch Em"</u>

<u>ATB:</u> With rifle triple tap the circle than double tap the rectangles then triple tap the circle. Make rifle safe. With pistols triple tap the circle then double tap the squares then triple tap the circle. With shot gun knock down 4 shot gun targets any order.





Stage #6



The Gunfight at Stone Corral

The **Gunfight at Stone Corral**, occurred in June 1893 and was the final shootout during the pursuit of the Sontag-Evans Gang. After months of searching and several previous encounters, a small posse under the command of Marshal George E. Gard ambushed John Sontag and Chris Evans at a corral near Visalia California and left one man dead and one wounded.

"Staging: Rifle loaded 10 rounds on the gun horse

Pistols loaded 5 rounds and holstered.

Shotgun open and empty gun horse

Gun Order: Rifle or shot gun first shooters choice Pistols last

Starting Position: Standing at the gun horse holding the reins shooter says "Ambush"

<u>ATB:</u> With shot gun knock down the 4 shot gun targets in any order make safe. Or with rifle put one shot on the rectangles then one shot on the squares then 6 on the circle. With pistols repeat the rifle instructions.
