#### **MEP Christine Anderson**

Christine is a distinguished, dynamic and results driven leader. Her career started in economics and she completed a Law degree prior to becoming an MEP in 2019, joining the group 'Identity and Democracy'.

Christine is a member of various committees in the European Parliament and was appointed to the Special Committee on the COVID-19 Pandemic. She has recently been selected as "Most Courageous Influential Leader of the Year" for 2023 by the International Association of Top Professionals (IAOTP).

Christine attributes her success to her perseverance, work ethic and love for her country. For the future, she aspires to bring about changes that will create a country in which future generations can take pride living in a society that is truly free and democratic.

#### **Lawyer Philipp Kruse**

Phillip Kruse is an Attorney at law with his own law firm in Zurich, Switzerland. He has 28 years of legal practise in business law and tax law. Since late 2020, Philipp has led over 25 ordinary court proceedings for parents, children, students and business owners in order to bring an end to unconstitutional corona-mandates.

On Monday 5<sup>th</sup> February 2024 Philipp will be delivering a presentation entitled "WHO's new pandemic treaties: Why a threat to sovereignty, democracy, economy and health?" #### **Dr Meryl Nass**

Meryl Ness is a board-certified internal medicine physician. She was the first person in the world to investigate an outbreak and prove it was due to biological warfare, publishing the results in 1992

(Anthrax epizootic - an epidemic that spreads from animals to humans, which occurred during Rhodesia's civil war, 1978-1980).

She developed a method for investigating epidemics to determine if they are natural or deliberately caused. She has consulted with IGO's, Governments and Ministries of health in several countries over the years regarding the prevention, investigation and mitigation of chemical and biological warfare and pandemics.

Over the past four years Meryl has written and spoken widely on all aspects of the pandemic, challenging the government narrative on the pandemic's origin, its treatment and COVID vaccinations. Her article on '58 ways in which the use of hydroxychloroquine for COVID was suppressed around the world' is a classic.

As one your constituents, I would appreciate it if you made every effort to attend this address.

I would also urge you to give your support at the three-hour debate on excess deaths, which I know is supported by many thousands of constituents across the UK. The debate has been accepted (but a date is yet to be set) so I would urge you to attend when it is confirmed.
