Step 1: Submit a Referral

We require a referral for testing services. Please ask your licensed medical provider (e.g., physician, psychiatrist) or a community-support professional (e.g., case worker, social worker) to send us a referral that includes the following:

- Client's full name
- Date of birth
- Phone number for scheduling
- **Type of testing requested (if known)** This helps ensure we include all assessments needed for the services you're seeking)
- Brief reason for the assessment referral

Step 2: Provide Insurance Information

Insurance verification is required before we can schedule your appointment. This helps ensure there are no hidden costs and that any necessary prior authorizations are completed in advance.

Required Insurance Info:

If the client is covered under a employer-sponsored plan, please also include:

- o Policyholders' first and last name
- o Policyholder's date of birth

If the client has government-sponsored insurance, we only need the client's information.

Note: Often employer-sponsored (private) plans require prior authorization. This process may take several days to a few weeks after submission.

Step 3: Appointment Scheduling

Once we have received the referral and verified insurance coverage, our team will contact you to schedule the assessment and walk you through the next steps.

Please note that our psychological testing and evaluations are scheduled on fixed dates and times, with limited flexibility. This is due to the high demand for these services and the extended duration of appointments that can last 3-4 hours. Once all necessary steps are completed, we will offer you the earliest available appointment.

Kindly be aware that we do not reschedule missed appointments or appointments not cancelled at least 92 hours (4 days) in advance. Please ensure you can attend your scheduled appointments and let use know as soon as possible if you need to reschedule.
