# **VEEMAH Neuropsychological Assessment Fee Policy**

A Neuropsychological Assessment helps us understand how a person thinks, learns, remembers, and manages emotions or behavior. It involves a series of activities, questions, and tests that examine areas such as attention, memory, problem-solving, language, motor skills, and emotional well-being.

The assessment results in a written report that provides valuable insight into a person's strengths and challenges. It may also offer important evidence to support diagnoses such as ADHD, learning disorders, memory concerns, Autism Spectrum Disorder (ASD), mood or anxiety disorders, and other conditions. The results can be used to guide treatment, provide educational accommodations, and overall support planning.

Please note that the assessment may require lengthy or multiple appointments, including interviews and testing sessions. These sessions are billed to your insurance or offered at a flat fee for self-pay clients. Your out-of-pocket costs may vary depending on your plan, copays, or deductibles. **Our fee structure is outlined below.** 

#### FOR CLIENTS USING INSURANCE

- Diagnostic Evaluation (Required for All Assessments) \$230
  - Every assessment begins with a diagnostic evaluation conducted as a interview with client and/or clients guardian(s).
  - This helps us gather background information, understand your concerns, and determine the most appropriate testing.
  - These fees are billed to your insurance, so the amount you pay may vary depending on your insurance plan, copays, or deductibles.
- Neuropsychological Assessment (Using Insurance)
  - First hour: \$250 The initial hour of testing
  - Each additional hour: \$200 Any extra time needed to complete the assessment.
  - These fees are billed to your insurance, so your responsibility may vary depending on your plan, co-pays, or deductibles.

### FOR CLIENTS SELF-PAY/NOT USING INSURANCE

- Neuropsychological Assessment (Self-Pay / Not Using Insurance)
  - o If you are paying out-of-pocket without insurance, the full assessment (including the required diagnostic evaluation) is a flat rate of \$1,000.

## **Payment Policy**

- If you are using insurance: a \$200 prepayment is required before your first appointment or during check-in. This payment will be applied toward the total cost of your assessment after claim is processed, the remainder of the bill will be sent to you via mail.
- If you are self-paying: the \$1,000 fee is due in full at the start of your appointment.

Payment for all clients seeking Neuropsychological Assessment can be made by credit/debit card or exact cash at check-in the date of your appointment or you can pay ahead online prior to arrival at https://veemah.com/pay

#### Insurance

Clients using health insurance, must provide current insurance information before your appointment. You are encouraged to contact your insurance company to verify your benefits. Please note verification over the phone does not guarantee full payment. Your bill is determined after your claim has been processed.

You are ultimately responsible for any charges not covered by your insurance, including copays, deductibles, or denied claims. All balances are due in a timely manner. Any account balance outstanding after 90 days must be paid in full by the patient. It is the patient's responsibility to work directly with their insurance company for any unpaid services.

## **Private Pay**

Clients paying privately (not through insurance) are required to pay the \$1,000 flat fee before or at the start of their appointment. Payment can be made by credit/debit card or cash at check-in before your appointment or online at <a href="https://veemah.com/pay">https://veemah.com/pay</a> before you arrive.

#### Late Cancellations and No-Shows

If you need to cancel or reschedule, please provide at least 24 hours' notice. Cancellations made with less than 24 hours' notice or missed appointments may result in a \$75 late cancellation/no-show fee. We do not reschedule no show clients or clients who do not give at least 24 hours notice of cancellation due to high demand for this service.

#### Failure to Pay

Our team is committed to providing confidential, compassionate, and effective care. Timely payment helps us continue offering services to all clients. If extenuating circumstances prevent payment, please contact our billing staff to discuss an acceptable payment arrangement. Failure to resolve unpaid balances may result in your account being sent to collections and/or a pause in services until the balance is addressed.
