Transfer of Ownership

Ownership of the puppy transfers to the Buyer only after the full adoption fee has been paid.

Fees and Payments

- Deposit due at signing: **\$250.00 (non-refundable)**

--Total adoption fee (including deposit):

*You must submit a breeding plan and be approved for breeding rights prior to adopting a puppy.

--Payment schedule (due at 8 weeks):

- Balance (with breeding rights): \$1,750.00
- All remaining balances must be paid on or before the date the puppy leaves the adoption site.

Refunds and Appearance

If the Seller does not have the Buyer's requested color/gender within one (1) year from the date the deposit is placed, the deposit may only be refunded at that time. The Seller does not guarantee specific markings or appearance (including ticking, spotting, or masks). These are not grounds for a deposit refund.
