Extended Stay Agreement

This Agreement is entered into between Stonesriver Kennel Brittany ("Breeder") and _____ ("Adopter") regarding the puppy identified below:

If your puppy stays beyond the scheduled adoption day, pre-arranged 8 weeks through 10 weeks.

Daily care: Feed, Water, etc. \$25.00 per day

If your puppy stays beyond the scheduled adoption day, pre-arranged 10 weeks through 12 weeks.

Daily care: Feed, Water, etc. \$35.00 per day

Dewormer \$10.00

Antiparasitic \$10.00

5-Way Vaccine administered at 10 weeks \$10.00

9-Way Vaccine \$25.00 administered at 12 weeks \$25.00

By signing this Agreement, both parties agree to the following terms:

1. Full Payment Requirement

Breeder acknowledges and agrees that the puppy must be paid for in full prior to the signing of this Agreement and prior to the puppy being held past the standard pickup date.

2. Puppy Hold Agreement

Breeder agrees to hold the above-referenced puppy until the agreed hold date listed above after full payment has been received. During this hold period, the puppy will remain in the care of the Breeder until adoption arrangements are completed.

3. Non-Refundable Payment

Adopter understands and agrees that all monies paid toward the puppy, including deposits and final payment, are non-refundable, if Adopter chooses to; back out, cancel, surrender, abandon, or otherwise fail to complete the adoption for any reason, no money shall be refunded.

4. Care During Hold Period

While the puppy remains in the care of the Breeder, the puppy will continue to receive routine daily care, feeding, socialization, and monitoring consistent with the Breeder's normal standards of care.

5. Health & Veterinary Care During Hold

Adopter understands and acknowledges that puppies are living animals and unforeseen health concerns, illnesses, injuries, or medical conditions may occur prior to adoption. The Breeder shall not be held financially or legally responsible for unforeseen health occurrences arising during the hold period.

6. Veterinary Expenses

Any veterinary expenses incurred during the hold period for emergency care, illness, injury, or unforeseen medical concerns after the signing of this Agreement will become the responsibility of the Adopter. Copies of veterinary records and invoices will be provided to the Adopter. In the event the puppy appears ill, injured, or in need of veterinary attention while in the Breeder's care, the Breeder will make reasonable efforts to contact the Adopter prior to seeking veterinary treatment. If immediate veterinary attention is deemed necessary for the puppy's health or

safety, the Breeder reserves the right to seek treatment without prior approval when the Adopter cannot be reached in a timely manner. In the event of accidental expiration of the puppy, the Adopter will be given the option of another puppy, if available. If another puppy is not available, the Adopter will have the option of choosing from another litter when available, no money will be refunded if the depositor chooses not to adopt the puppy.

7. No Guarantee Against Future Illness

Adopter understands that despite proper care, veterinary oversight, vaccinations, deworming protocols, preventative care, and sanitation measures, no breeder can guarantee that a puppy will remain free from illness, parasites, stress-related conditions, environmental exposure, or other health-related issues after leaving the Breeder's care.

8. Entire Agreement

This agreement supplements the original Adoption Contract and does not replace any existing terms unless specifically stated herein. All other provisions of the original contract remain in full force and effect.
