Parent Policy Update & Acknowledgement

Effective July 6, 2026

Assumptions of Risk: I voluntarily assume the ordinary risks associated with my child's participation in Prolific Kids Club LLC programs, including exposures to common illnesses and injuries that may occur during normal activities.

Behavior Acknowledgement: I acknowledge that my child will follow Prolific Kids Club LLC behavior expectations, anti-bullying policy, and discipline procedures and agree to support these policies.

Communicable Illness Acknowledgement: I understand that participation in group programs may expose my child to common communicable illnesses. While Prolific Kids Club LLC takes reasonable precautions to promote a healthy environment, it cannot guarantee that exposure to illness will not occur.

Health and Illness: I acknowledge that if my child has a fever (100.4°F or higher), vomiting, diarrhea, or symptoms of a contagious illness, I will keep my child home until they have been symptom-free for at least 24 hours without the use of fever-reducing medication, or until they are cleared to return by a healthcare provider when appropriate.

Late Pick-Up Fees: After the 5:00pm grace period, late-fees will apply as follows: 5:11-5:30pm=\$15, 5:30-6:00=\$30. After 6:00pm= \$1 per minute per child until pick-up.

Late Pick-Up Policy: Families enrolled in the 5:00pm pick-up schedule will be provided a courtesy 10 minute grace period (until 5:10pm) when advance notice is given before 5:00pm. This grace period is intended for occasional, unforeseen circumstances and is not an extension of the scheduled pick-up time. Families who use the grace period more than 5x within a calendar month will automatically be moved to the 6:00pm pick-up schedule. Prolific Kids Club LLC reserves the right to adjust a family's contracted

pick-up schedule at any time if repeated late pick-ups indicate that a later schedule better reflects the families regular attendance needs.

Late-Pick Up Acknowledgement: I understand that Prolific Kids Club LLC closes promptly at 6:00pm if my child is not picked up one time, I agree to pay all applicable late pick-up fees. I understand that repeated late pick-up will result in the loss of my child's enrollment.
