LICENSE-EXEMPT AFTER-SCHOOL PROGRAM AGREEMENT

1. PROGRAM DESCRIPTION

Prolific Kids Club is an after-school enrichment program that provides structured activities including sports, homework support, and recreational play. This program is designed to supplement the school day and is not a licensed child daycare facility.

2. LICENSE-EXEMPT STATUS

Prolific Kids Club operates as a license-exempt program under guidelines established by the California Department of Social Services.

By enrolling your child, you acknowledge and understand that:

- This program is NOT a licensed childcare facility
- The program is not subject to the same regulations as licensed daycare centers
- Care is provided in a recreational and enrichment-based setting, not as custodial childcare

3. HOURS OF OPERATION

- Program operates after regular school hours only
- This program does not provide full-day childcare services
- Parents/guardians are responsible for ensuring timely pickup

4. ENROLLMENT REQUIREMENTS

- Child must be currently enrolled in the school
- Emergency contact information must be provided and kept current
- Parent/guardian agrees to all program policies upon enrollment

5. SUPERVISION & ACTIVITIES

- Children participate in group-based activities including sports, games, and homework time
- While staff provide supervision, this program promotes independence, responsibility, and participation
- Children may be expected to assist in basic clean-up of materials used during activities

6. HEALTH & SAFETY

- Staff are trained in basic safety procedures, including CPR/First Aid
- In case of emergency, staff will contact parent/guardian and/or emergency services
- Parent authorizes staff to seek medical attention if necessary

7. BEHAVIOR POLICY

Prolific Kids Club maintains a safe and respectful environment.

The program reserves the right to:

- Address behavioral concerns
- Implement corrective action
- Suspend or terminate enrollment at any time, at the program's discretion, for safety or policy violations

8. RELEASE OF LIABILITY

By enrolling your child, you agree that:

- Participation in physical and recreational activities carries inherent risks
- You voluntarily assume all risks associated with participation
- Prolific Kids Club, Goethe International Charter School, and Los Angeles Unified School District and its staff shall not be held liable for injuries, accidents, or incidents that may occur, except as required by law

9. PAYMENT & WITHDRAWAL

- Tuition is due as agreed upon in the registration form
- Failure to make payment may result in immediate disenrollment
- Withdrawal must be communicated in writing

10. PICK-UP POLICY

- Only authorized individuals may pick up your child
- Identification may be required
- Late pick-ups may result in additional fees and/or termination of services

11. AGREEMENT

By signing below, I acknowledge that I have read, understood, and agree to all terms outlined in this agreement. I understand that this program is license-exempt and not a daycare facility.
