


2024 Annual Impact Report

Total assisted families (468 are repeats)

818

Received services through our community food pantry. 350 are repeats.

- 112 Requested housing support & 78 were assisted. (97 were denied due to funding and referred out, 71 received assistance from referral & 7 received rental assistance through our organization).

In its first year, the pantry distributed hundreds of food boxes and provided gift cards for fresh produce, ensuring families receive well-rounded nutritional support.

### Summertime Sno Youth Luncheon and Awards

This summer, our Summertime Sno Youth Program concluded with a celebratory luncheon and awards ceremony. The program boosted participants' math skills, self-esteem, and leadership abilities through community service and volunteer opportunities. At the luncheon, we honored the youth's dedication and presented rewards based on their service hours, inspiring them to continue making a difference.
