



LEAVING A GIFT IN YOUR WILL TO DOG A.I.D.

Dog Assistance in Disability (A.I.D.) is a unique organisation, empowering disabled people to train their own pet dogs as Assistance Dogs, supported by professional dog trainers as volunteers. Whatever you are able to leave as a gift will make a big difference to our work.

There are three types of gift you can leave in your Will to support our work:

1. A share of your estate (called a residuary legacy) is the whole or a percentage of the remainder of your estate, once all other legacies and costs have been paid. This is a great way to provide for your family and friends and also support disabled people through a gift to Dog A.I.D.
2. A specific sum (called a pecuniary legacy) e.g. £10,000.
3. A specific item of value such as antiques or jewellery.

Once you have decided what type of gift you would like to leave in your Will, please ask your solicitor to use one of the suggested wordings below.

FOR A RESIDUAL LEGACY

“I give the whole or a share (state the percentage) of the residue of my estate to Dog Assistance in Disability (Registered Charity No. 1178719) of Earlyworld House, 7 Darwin Court, Oxon Business Park, Shrewsbury, Shropshire, SY3 5AL, for the general purposes of Dog Assistance in Disability for its charitable purposes, and I declare that the receipt of their Treasurer or any other proper officer of Dog Assistance in Disability shall be sufficient discharge to my executors.”

FOR A PECUNIARY LEGACY

“I give free of tax to Dog Assistance in Disability (Registered Charity No. 1178719) of Earlyworld House, 7 Darwin Court, Oxon Business Park, Shrewsbury, Shropshire, SY3 5AL, the sum of £ (amount in figures, amount in words) for the general purposes of Dog Assistance in Disability for its charitable

purposes, and I declare that the and I declare that the receipt of their Treasurer or any other proper officer of Dog Assistance in Disability shall be sufficient discharge to my executors.”

FOR A SPECIFIC ITEM

“I give to Dog Assistance in Disability (Registered Charity No. 1178719) of Earlyworld House, 7 Darwin Court, Oxon Business Park, Shrewsbury, Shropshire, SY3 5AL, (write here what you wish to give) for the general purposes of Dog Assistance in Disability for its charitable purposes, and I declare that the and I declare that the receipt of their Treasurer or any other proper officer of Dog Assistance in Disability shall be sufficient discharge to my executors.”.
